RECRUITMENT UNDER NORMAL REGULATIONS OF PROFESSIONAL ENGINEERS (HIGHER MINISTRY OF SUPPLY. DEPARTMENTAL GRADES) IN THE

1. Sex and Marriage. (i) Both men and women may compete under these Regulations.

(ii) Married women who have formerly been established (iii) Married women who have formerly been established Civil Servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their hus-bands, or whose husbands suffer without hope of recovery from total physical or worth inspacing without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

2. Age.

5. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.
