RECONSTRUCTION COMPETITION FOR APPOINTMENTS AS CARTO-GRAPHICAL DRAUGHTSMEN OR SURVEYORS IN THE ORDNANCE SURVEY.

1. Age. Candidates must be at least 16 and under 46 years of age on 1st April 1951 (*i.e.*, they must have been born on or after 2nd April 1905, and on or before 1st April 1935).

2. Sex. Both men and women may compete under these Regulations.

3. Nationality. Candidates must be British subjects.
 They must also satisfy one of the following conditions :
 (a) If natural-born British subjects, they must either
 (i) have at least one parent who is or was at death
 a British subjects on a set one parent who is or was at death

(i) have at least one parent who is or was at death a British subject; or
(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
(b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing, or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualifications and Experience. Candidates will generally be required to show that they have had two years' experience on drawing office or surveying work. But the Commissioners will be prepared to consider :-- (a) Candidates specially well qualified who have had not less than one year's practical experience.
(b) Candidates of School Certificate standard generally who can satisfy the Commissioners of their aptitude for drawing office or surveying work but who have been unable for good reason (e.g., service in the Forces; age) to acquire the necessary experience.

5. Health and Character. Every successful candidate must satisfy the Commissioners as to his or her health and character.

6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

7. Competition. The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those who are considered to be specially suitable for the posts for which they are being considered. The Board will posts for which they are being considered. The Board will take into consideration the candidates' record of education and experience, if any, recommendations from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The decision of the Civil Service Commissioners shall be final.

8. Candidates Trained as Teachers. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appro-priate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

9. Assignments. Candidates will be required to state on 9. Assignments: Candidates will be required to state on their applications forms whether they prefer drawing or surveying work. It will rest with the Ordnance Survey Authorities to determine to which duty successful candidates shall be allocated, but due regard will be paid, as far as possible, to candidates' preferences.

10. Canvassing. Any attempt on the part of candidates to enlist support for their application through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, or other educational insitution, in the Excess or otherwise Forces, or otherwise.

11. Fee. A successful candidate shall be required to pay a fee of 12s. 6d. before the issue of a certificate of qualification for appointment.
