WHEREAS the Secretary of State for Scotland has, in WHEREAS the Secretary of State for Scotland has, in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act, 1855 (18 & 19 Vict., c. 68), made a Representation that he has received a copy of an Interlocutor dated 12th July 1951, pronounced by the Sheriff-Substitute of Inverness, Moray, Nairn, and Ross and Cromarty, at Inverness, finding that the former burial ground on the island of Eriskay, in the Parish of South Uist and County of Inverness, known as The Old Burial Ground, Eriskay, is in a condition which is dangerous to health and contrary to decency;

And Whereas in the said Representation it is recommended that in terms of Section 5 of the aforesaid Act burials be forthwith discontinued in the said burial ground except for the burial therein of (1) persons whom the County Council of Inverness may specially authorize to be buried in the said burial ground; and (2) cremated human remains.

And Whereas by an Order in Council of the 4th day of October 1951, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 10th day

tion by a Committee of the Privy Council on the 10th day of December 1951, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order, or Notice thereof, should be fixed on the doors of the Church of or on some other conspicuous places within the Parish of South Uist and Island of Eriskay one month before the said 10th day of December 1951:

And Whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council.

Now, Therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order and it is hereby ordered as follows, viz.:—

1. That in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the former burial ground on the island of Eriskay, in the Parish of South Uist and County of Inverness, known as The Old Burial Ground, Eriskay, except for the burial therein of :-

(1) persons whom the County Council of Inverness may specially authorize to be buried in the said burial ground; and

(2) cremated human remains; provided that the exercise of the right of burial be not injurious to health or offensive or contrary to decency, that intimation be

given to the District Sanitary Inspector of the County of Inverness not later than the day preceding that on which a grave is to be opened, and that no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

2. This Order may be cited as the Burial Grounds (Scotland) (Old Burial Ground, Eriskay) Order, 1952.
