The Secretary of State for Scotland, in exercise of his powers under the Destructive Insects and Pests Acts, 1877 to 1927, has made the Blackcurrant Reversion (Scotland) Order, 1952, which comes into operation on 1st March 1952.

The Order makes provision for the examination of blackcurrant plants suspected of being affected with reversion, and gives power to the Secretary of State to order the destruction of any plants found to be so affected. Such action will be taken if it appears from a complaint made by a person who is the occupier of land on which blackcurrant plants are growing that any blackcurrant plants growing on any land in the vicinity of the land occupied by the person making the complaint is so affected with blackcurrant reversion that other blackcurrant plants may also become so affected.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Section 10 of the Finance Act, 1926, entitled the Safeguarding of Industries (Exemption) (No. 2) Order, 1952, which continues until 18th August 1952, with certain additions and deletions, the exemption from Key Industry duty of articles exempted from that duty by previous Orders which expire on the 19th February 1952.

A further Order entitled the Additional Import Duties (No. 1) Order 1952, has been made under Section 19 of the Import Duties Act, 1932. This Order continues for a similar period the reduction from 33½ per cent. to 10 per cent. of the duty chargeable on acetone under that Act.

The Orders come into operation on the 20th February 1952, and have been published as Statutory Instruments 1952, Nos. 277 and 276.

Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

BURGH OF GRANGEMOUTH.
