CEREMONIAL observed at proclaiming HER MAJESTY QUEEN ELIZABETH THE SECOND at the

Mercat Cross of Edinburgh, the 8th day of February 1952.

THIS day, in consequence of an Order in Council of the 6th day of February, Her Majesty Queen Queen Elizabeth II. was proclaimed between the hours of twelve noon and two afternoon, first at the Mercat Cross, then at the Gate of the Castle, then in front of Her Majesty's Royal Palace of Holyroodhouse, and lastly at the Pier and Shore of Leith, with the usual solemnities.

The Lord Provost, Magistrates, and Council of the City of Edinburgh, along with the persons and public bodies after-mentioned, assembled at the Parliament House at Half-past Eleven o'clock A.M., for the purpose of assisting at the ceremony of Proclaiming Her Majesty the Queen. The Judges, Magistrates, and other official persons appeared in their robes or uniforms.

The Proce Lion was marshalled in the following order by Rothesay Herald and Carrick Pursuivant, and moved from the Parliament House at 11.45 A.M.

The Procession left Parliament House at 11.45 A.M. and proceeded to the Mercat Cross. The Queen's Bodyguard for Scotland (Royal Company of Archers), under command of Brigadier T. Grainger Stewart, M.C., T.D., A.D.C., and the Guard of Honour, consisting of three officers and fifty rank and file of the 1st Battalion of the Seaforth Highlanders, were drawn up at the west and north of the Cross respectively, whilst the Band of the 1st Battalion of the Seaforth Highlanders was at the east of the Cross. The other persons and public bodies attending the Proclamation, with the exception of those after-mentioned, were drawn up in the open space to the north of the Cross. On reaching the Cross, the Lord Provost, accompanied by the Town Clerk, the Chief City Officer, sword, mace, and halbert bearers, proceeded to the balcony of the Cross and after a fanfare of trumpets read the Proclamation to the inhabitants of the City of Edinburgh. At the close of the Proclamation by the Lord Provost, the Pursuivants, Heralds, Lord Lyon King of Arms, and Sheriff, having now ascended to the balcony of the Cross, the Proclamation was, after a fanfare of trumpets, made to the people of the Kingdom of Scotland, and at request of the Sheriff to the lieges of the Sheriffdom of the Lothians and Peebles, by the Lord Lyon King of Arms, who did thereafter proclaim the style and titles of Her Majesty, with a flourish of trumpets from Her Majesty's Household Trumpeters, a Royal Salute from the Royal Company of Archers and from the Guard of Honour, and a Royal Salute of twenty-one guns from the guns of the Castle. Thereafter the Lord Lyon King of Arms called for three cheers for Her Majesty, which were enthusiastically given by the vast assemblage of spectators.

The Procession, consisting of Her Majesty's Household Trumpeters and Officers of Arms, the Lord Provost, Magistrates, and Council of the City, and Officers of the Headquarters Staff of the Scottish Command and others then proceeded to the Gate of the Castle, where they were received by the Governor of the Castle, Sir Gordon H. A. MacMillan of MacMillan, K.C.B., C.B.E., D.S.O., M.C., and by a Guard of Honour furnished by the Lowland Brigade and Depot, Royal Scots. The Proclamation was read by Albany Herald with the usual solemnities.

The Procession returned down the Castle Hill and High Street, the Officers of the Headquarters Staff having now fallen out, and proceeded by way of the Canongate to the Royal Palace of Holyroodhouse, where they were received by His Grace the Duke of Hamilton, P.C., K.T., G.C.V.O., Hereditary Keeper of the Palace of Holyroodhouse, a Guard of Honour furnished by the 69th H.A.A. Regiment, Royal Artillery, and by the Bailie and High Constables of Holyrood. Proclamation was then made in front of the chief doorway by Marchmont Herald with solemnities as before.

Thereafter the State Trumpeters, Officers of Arms, Lord Provost, and Magistrates proceeded to the Pier and Shore of Leith, where the Proclamation was made by Rothesay Herald with the same solemnities, the Guard of Honour being furnished by two officers and ratings of H.M.S. Widemouth Bay.

NOTICE OF SUBMISSION OF PRELIMINARY DRAFT REGULATIONS ENTITLED THE NATIONAL INSURANCE (CLAIMS AND PAYMENTS) AMEND-MENT REGULATIONS, 1952.

In accordance with Section 77 of the National Insurance Act, 1946, the National Insurance Advisory Committee give notice that they have received from the Minister of National Insurance for consideration and report thereon the preliminary draft of Regulations entitled the National Insurance (Claims and Payments) Amendment Regulations, 1952.

A short Explanatory Note on these Regulations is appended to this Notice.

The Committee will take into consideration any objection, made by or on behalf of persons affected, sent to them before Tuesday, 22nd April 1952. Having regard to the terms of the Act, which provides that objections must be made within a period of 28 days at most, the Committee are unable to allow a longer period within which objections may be sub-mitted. If on objections is explained within the averagible allow a longer period within which objections may be sub-mitted. If an objection is submitted within the prescribed time, however, the Committee will be prepared, if they are satisfied that sufficient grounds exist, to allow the later submission of evidence or explanation in support of the objection. EXPLANATORY NOTE.

These Regulations amend the National Insurance (Claims and Payments) Regulations, 1948, by varying certain of the existing time limits relating either to the claiming of benefit, disqualifications for late claim, or the obtaining payment of benefit. They also consolidate the provisions of those Regulations (including the relevant amendments) relating to the times for claiming benefit and for giving notice of incapacity and the disqualifications for late claims and notices.
