PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Secretary of State for Scotland has, in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act, 1855 (18 & 19 Vict. c. 68), made a Representation that he has received a copy of an Interlocutor dated 8th May 1951, pronounced by the Sheriff-Substitute of Perth and Angus at Perth, finding that the Burial Ground known as Rattray Churchyard, in the Parish of Rattray and County of Perth, is in a condition which is dangerous to health and is overcrowded:

And whereas in the said representation it is recommended that in terms of Section 5 of the aforesaid Act burials be forthwith discontinued in the said Burial Ground subject to the exceptions hereinafter mentioned:

And whereas by an Order in Council of the 23rd day of May 1952, Notice of such representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 12th day of July 1952, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof, should be fixed on the doors of the Church of or on some other conspicuous places within the Parish of Rattray one month before the said 12th day of July 1952:

And whereas Notice of the said representation and of the time when it pleased Her Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order and it is hereby ordered as follows:

1. That in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the former Burial Ground in the Parish of Rattray and County of Perth except for the burial therein of:—

- (1) spouses of persons buried in the said Burial Ground at the date of closure;
- (2) persons having one or more of their children buried in the said Burial Ground at the date of closure;
- (3) unmarried persons whose parents are buried in the said Burial Ground at the date of closure;
- (4) unmarried persons resident in the Parish of Rattray whose brothers or sisters are buried in the said Burial Ground at the date of closure;
- (5) James Donaldson, Douglasbridge, Old Rattray;
- (6) any persons whom the Town Council of the Burgh of Blairgowrie and Rattray may specially authorize to be buried in the said Burial Ground; and
- (7) cremated human remains.

Provided that the exercise of the right of burial be not injurious to health or offensive or contrary to decency, that intimation of a burial be given to the Sanitary Inspector of the Burgh of Blairgowrie and Rattray not later than the day preceding that on which the grave is to be opened, and

that no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of five feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

2. This Order may be cited as the Burial Grounds (Scotland) (Parish of Rattray Churchyard), Order, 1952.

Now know ye that We reposing great trust and confidence in your knowledge and ability have authorized and appointed and do by these Presents authorize and appoint you the said Earl of Balfour; Sir Thomas Robert Gardiner; Sir William Gavin; Sir Alexander Murray Stephen; Sir William Hugh Stobart Chance; Agnes, Lady Dollan; Claude William Guillebaud; Duncan Fraser; John M'Naughton; May Eudora Campbell; John Spencer Muirhead; William Paul M'Ginniss; John Stirling of Fairburn; James Hutchison Cockburn; and Francis Henry Normand Walker to be Our Commissioners for the purpose of the said enquiry:

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any four or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; to call for information in writing; and also to call for, have access to and examine all such books, documents, registers, and records as may afford you the fullest information on the subject, and to enquire of and concerning the premises by all other lawful ways and means whatsoever;

And We do by these Presents authorize and empower you, or any of you, to visit and inspect personally such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid;

And We do by these presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any four or more of you, may from time to time proceed in the execution thereof, and of every matter and thing herein contained, although the same be not continued from time to time by adjournment;

And We do further ordain that you, or any four or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do;

And Our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any four or more of you, your opinion upon the matters herein submitted for your consideration.

And We Will and Command the said Letters Patent to be extended in the most ample form and to pass the Seal aforesaid *per saltum* without passing any other Seal or Register. For doing whereof these Presents shall be to the Director of our Chancery for writing the same and to the Keeper of the said Seal for causing the same to be appended thereto a sufficient Warrant.

CORONATION OF HER MAJESTY.

COURT OF CLAIMS.

The Right Honourable the Commissioners appointed by Her Majesty to hear and determine all Claims of Services to be performed at the time of Her Majesty's Coronation (except those dispensed with by Her Majesty's Royal Proclamation of the 6th day of June last) and of fees to be received for the same, at their meeting held at the Council Office, Whitehall, on the 21st day of July 1952, resolved as follows:—

(a) All claims must be made by petition. Petitions may be sent under cover to the Clerks to the Court of Claims, Privy Council Office, Downing Street, London, S.W.1.

(b) Petitioners are not required to appear in person before the Court unless summoned.

(c) Petitioners may appear by Counsel, solicitors, or agents.

(d) If a claim was admitted in 1936 or 1937 the petitioner or his present representative should lodge a short formal petition stating that he is the same petitioner, or his representative, and, if a representative, in what capacity, and that the petition was allowed in 1936 or 1937.

(e) If there is no counterclaim, the Clerks shall forthwith place the claim in the list in order that it may be formally admitted upon the Court being satisfied that the claimant represents the person whose claim was admitted in 1936 or 1937. In these cases, the petitioner need not appear in person or by Counsel, solicitor, or agent.

(f) The Clerks shall not place in the list any claim excluded by the Court in 1936 on the ground that the claim was inappropriate to the Coronation by reason of the Royal Proclamation.

(g) Any claim now made, which was referred by the Court in 1936 to the Executive Committee for the purposes of arrangements for the Coronation, shall be referred by the Clerks to the same Committee.

(h) Petitioners are to present their claims by the 10th day of October next.

(i) Petitions shall be in the form following:—

“To the Right Honourable the Commissioners appointed to hear, receive, and determine the Petitions and Claims concerning the Services to be done and performed at Her Majesty's Coronation.

The Petition and Claim of

(Here state name, title, and abode of petitioner.)

Sheweth that

(Here set out the Claim and the facts on which it is founded.)

Your Petitioner therefore claims

(Here repeat the Claim.)

And your Petitioner will ever pray etc.

(Signature of Petitioner.)”

Each Petition shall be accompanied by twelve copies, which may be printed or reproduced by type, lithography, photostat, or stencil duplicating, and the type to be used shall be a type producing a clear and legible impression.

The Commissioners are required by the Proclamation to exclude from their consideration such claims as may be submitted to them in respect of rights or services connected with the parts of the ceremonial heretofore performed in Westminster Hall, and with the Procession, the Ceremony being confined to Westminster Abbey.

Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated.

For posts in the Air Ministry the qualifications required are :—

General Certificate of Education at Ordinary level or School Certificate or equivalent in appropriate subjects.

(ii) Candidates who have left school recently must be able to demonstrate their aptitude for this class of draughtsmanship. All other candidates must have had at least one year's appropriate experience in a Drawing Office.

REVIEW OF CONDITIONS FOR AWARD OF
CREDITS DURING FULL TIME TRAINING.

Under Section 41 of the National Insurance Act, 1946, the Minister of National Insurance has asked the National Insurance Advisory Committee :—

" To review the conditions under which a person who enters on a course of full-time training after a period of employment or self-employment is excused from liability to pay National Insurance contributions for the period of that course and is awarded credits for that period."

The Committee will be glad to take into consideration representations from organizations and persons concerned with this question.
