DALKEITH NORTHERN BY-PASS.

The Ministry of Transport hereby gives notice that he proposes to make an Order under Section 1 of the Trunk Roads Act, 1946, as extended by Section 14 of the Special Roads Act, 1949, the effect of which will be that a by pass which he proposes to construct to the north of Dalkeith in the County of Midlothian will become a trunk road on the date when the Order comes into operation and the lengths of the Newcastle-upon Tyne-Edinburgh Trunk Road to be superseded thereby will cease to be trunk roads on the sixteenth day of May next after the date on which notice is given by the Minister to the Midlothian County Council (who will thereafter become the highway authority responsible for those lengths) that the by-pass is opened for through traffic.
