IMPORTATION OF **PLANTS** (GENERAL LICENCE) (SCOTLAND) ORDER, 1953, AND THE IMPORTATION OF PLANTS FROM BELGIUM, FRANCE, AND THE NETHERLANDS (GENERAL LICENCE) (SCOTLAND) ORDER, 1953

The Secretary of State for Scotland has made the above Orders which came into operation on 1st April 1953.

The first-named Order revokes and consolidates two General Licences, made in 1949 and 1952 respectively, modifying the requirements of the Importation of Plants (Scotland) Orders, 1947 to 1943, on the importation of certain produce from European countries, the United States of America, and Canada. The kinds of produce affected by this Order are the same as those in the aforesaid General Licences, but alterations are made in the form of the certificate to accompany the produce the certificate to accompany the produce.

The Importation of Plants (Scotland) Orders, 1947 to 1953, impose restrictions on the landing in Scotland of trees, shrubs, plants, raw vegetables, and potatoes. The Importation of Plants from Belgium, France, and the Netherlands (General Licence) (Scotland) Order, 1953, modifies these restrictions in the case of certain produce imported from Belgium, France, and the Netherlands during specified periods of the year 1953.
