The King has been pleased to nominate, constitute, and appoint Robert Dundas, Esq. writer to the signet, to be Conjunct Clerk to the Bills in the office of his Majesty's registers and rolls in Scotland, vacant by the death of Robert Anstruther, Esq.

The following addresses have been transmitted to his Majesty's Principal Secretary of State for the Home Department, and have been presented to the King; his Majesty was pleased to receive them in the most gracious manner.

To his Majesty, the KING.

May it please your Majesty. We, your Majesty's very faithful subjects, the Magistrates and Council of Paisley, feel it a duty incumbent upon us, at this singular æra of your Majesty's reign, to transmit to your Majesty the most cordial assurance of our sincere regard for your Majesty's person and family, and undiminished attachment to the government over which your Majesty has so long and so honourably presided.
