Regulations for the Recruitment of Plans Assistants in H.M. Land Registry

1. Age.

Candidates must be at least 16 and under 18 years of age on 1st March 1954. Bur candidates who have served in any established post

PRICE DETERMINATIONS BY THE IRON AND STEEL BOARD.
