And whereas by an Order in Council of the 12th day of September 1953, notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 29th day of October 1953, and that the said Order or Notice thereof should be published in the Edinburgh Cozatte and 29th day of October 1953, and that the said Order or Notice thereof should be published in the Edinburgh Gazette, and that copies of the said Order or Notice should be fixed on the doors of the churches of, or on some other conspicuous places within, the Parish of Crawford one month before the said 29th day of October 1953:

And whereas Notice of the said Representation and of the time when it pleased Her Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1. That in terms of Section 5 of the Burial Grounds.

1. That in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the Burial Ground at Leadhills in the Parish of Crawford and County of Lanark, known as the Old Portion of Leadhills Graveyard, except for the burial of cremated human remains.

REGULATIONS FOR THE RECRUITMENT OF H.M. INSPECTORS OF FACTORIES (CLASS II), MINISTRY OF LABOUR AND NATIONAL SERVICE

Candidates must be at least 21 and under 30 years of age on 1st November 1953. But (a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct from his actual age the period of such service rendered before 1st November 1953; (b) older candidates having exceptionally suitable qualifications may be considered if they were under 34 years of age on 1st November 1953.

#### Sex and Marriage.

(i) Both men and women may compete under these Regulations.

(ii) Married women who have formerly been established (ii) Married Women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointmental the preprince gratuity gold. the marriage gratuity paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

- (i) have at least one parent who is or was at death a British subject; or

# 4. Qualifications.

Candidates must be university graduates in Engineering, Chemistry, Physics, or Metallurgy, or have comparable technical qualifications (e.g., A.M.I.Mech.E.). The Commissioners may dispense with this requirement in the case of a candidate who appears to them to be exceptionally well fitted by reason of considerable works or other special practical experience.

#### 5. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

#### Competition.

The candidates who appear from their applications to have the best qualifications and experience will be invited to interview in London before a Selection Board, which will recommend to the Civil Service Commissioners those considered most suitable for appointment. The Board will take into consideration the candidates' record of education and experience, recommendations from referees named by the candidates, and the personal qualities of the candidates as shown at the interview. The decision of the Commissioners will be for missioners will be final.

### 7. Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Minister of Education, the Scottish Education Department, the Minister of Education for Northern Ireland) has been notified to the Commissioners.
