REGULATIONS FOR THE RECRUITMENT OF TECHNICAL CLERKS IN HER MAJESTY'S STATIONERY OFFICE

1. Age. Candidates must be at least 22 and under 28 years of age on 1st March 1954. But

This will consist of an informal oral test of the candidate's technical knowledge of the subject in which he is competing, followed by an interview for the assessment of personal qualities before a board on which the Commissioners and Her Majesty's Stationery Office will be represented.
