The surface of this material will be covered with a 4" layer of bituminised sand to seal the filling material. On top of the bituminised sand, a rough stone surface will be formed 15" deep, composed of stones laid on edge. The face of this stonework slope will be divided into compartments, almost square on plan, by transverse reinforced concrete beams placed at 25 feet intervals along the defence work. The top of the stonework slope will be about 15 feet intervals. The top of the wave-wall will be about 15 feet 9 inches above High Water ordinary spring tides, and the protective works will extend from about 400 feet south of the existing Cafe to 150 feet.
