The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz:—

Regulations for the recruitment of Civilian Instructors (men) under the War Office.

- 1. Men only are eligible.
- 2. There are no age limits, but Departments expect regular and effective service for a reasonable period, and this requirement will be taken into account.
- 3. Candidates must be natural-born Briti h subjects born within the United Kingdom or in one of the self-governing D minions of parents also born within the United Kingdom or in one of the self-governing Dominions. No departure from this rule will be made without the special permission of the Secretary of State for War and then only in exceptional cases and in favour of candidates who are British subjects and who also satisfy one of the following conditions:—
 - (a) If natural-born British subjects, they must either:
 - (i) have at least one parent who is, or was at death, a British subject; or
 - (ii) have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown tor at least five years out of the last eight years preceding the date of their appointment.
 - (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Civil Service Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of na ional service, that an exception may properly be made in their favour.
- 4. Candidates must be (a) experienced and fully-skilled in their particular trade, craft or subject, (b) able to teach their trade, craft or subject, and (c) able to supervise the work, and maintain control, of trainees engaged in their trade, craft or subject.

Candidates should have undergone the training usual in their particular trade, craft or subiect, followed by practical experience on fully-skilled work for a reasonable number of years (normally not less than five years in a craft trade). These provisions may be waived only exceptionally for individual candidates whose training in the trade, craft or subject and practical experience are comparable to the qualifications normally required. It is desirable for candidates to posts in Grade III (X trades) to be in post ession of an Ord ary National Certificate or City and Guilds Certificate or cau alent qualifications in the appropriate subject where such qualifications exist.

- 5. Tho e candidates who appear from their applications to have the best qualifications and exp rience will be required to take a test and will be summoned to in eview before a Selection Board which will recommend for the vacancy existing the candidate who seems to be most suitable.
- 6. Any attempt on the part of candidates to enlist support for their amplications through members of Parliament or other influential persons will disqualify them for appointment.
- 7. The necessary number of candidates will be appointed in an unestablished capacity subject to their satisfying the Civi Service Commissioners that they are eligible for appointment in respect of age, nationality, health and character and to the payment of a fee of 5s.
- 8. After a minimum qualifying period of two vear' un sablished service in the class Civilian In tructors appointed under these Regulations may be considered for appointmen to the established staff as and when vacancies occur thereon, if they are recommended by their Department as qualified in other respects. Those so considered will appear before a final Selection Board set up by the Civil Service Commissioners, which will recommend to the Commissioners the candidates who appear to be qualified.
- 9. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a further fee as follows is payable before the certificate of qualification can be issued:—

Grades III and IV

15s., being the balance of the prescribed fee of £1.

Grade V

10s., being the balance of the prescribed fee of 15s.

I FORTATION OF PLANTS, PLANT PRODUCTS AND SEEDS

THE Sccretary of S ate for Scotland has made two Orders under the Destructive Insects and Pests Ac.s, 1877 to 1927, entitled The Import ton of Plants (Scotland) Order, 1955 (S.I. 1955 No. 4 5 (S 44) and the Importation of Vegetables Sco land) Order, 1955 S.I. 1955 No. 404 (S.43)).

The first-named Order consolidates with amendments The Importation of Plants (Scolland) Orders 1947-54, The Import1 n of Plants (General Licence) (Scotland) Orders 1953-54
nd the Importation of Raw Cherries (Scotland) Order, 1954, prohibits or restricts the importation into Scotland (except der licence) of a revised list of plants and plant products

prohibits or restricts the importation into Scotland (except der licence) of a revised list of plants and plant products. Simplified forms of health certificates to accompany imports are prescribed in the Order. Provision is made for the inspection of imported produce, for the disposal of any found to be unhealthy and for the certification and release on application and payment of a fee, of healthy consignments

unaccompanied by the required certificate of the exporting country. The Order will come into operation on 1st April 1955, except provisions relating to imports of certain speds which will operate as from 1st July 1956.

The second is a seasonal Order and relaxes for prescribed periods in 1955 general restrictions imposed by the first Order. The relaxations relate to certain vegetables imported from specified districts in Belgium, France and the Netherlands and will come into one ation on 1st April 1955.
