ROYAL WARRANT.

ELIZABETH R.

WHEREAS We deem it expedient to make provision for the pensions and associated benefits of certain members of the former Indian and Burma Armed Forces which have not hitherto been promulgated:

OUR WILL AND PLEASURE IS that the pensions, or portions of pensions, and connected allowances specified in the Schedules to this Our Warrant shall be paid, or shall continue to be paid, in accordance with the provisions contained in those Schedules, with effect from the 1st day of April 1955.

Given at Our Court of St. James on the twenty-first day of May 1955, in the Fourth Year of Our Reign.

By HER MAJESTY'S COMMAND.

FIRST SCHEDULE.

Home.

Application to certain officers and warrant officers of the former Royal Indian Navy, and their dependants, and to certain officers and soldiers of the former armed forces of Burma and their dependants, of increases in pension to correspond as near as may be with the benefits provided in the case of certain civil pensions by the Pensions (Increase) Act, 1952.

1. This schedule relates to the following pensions:—

(a) Officers' service pension and the service portion of disability pension, if assessed under Regulations in force before the 1st September 1950.

(b) Warrant officers' and soldiers' service pensions if assessed under Regulations in force before the 1st September, 1950;

(c) Widows' "ordinary" pensions and children's "ordinary" compassionate allowances, other than those to which (6) of the Third Schedule of this Warrant applies;

(d) Victoria Cross annuities of £10.

2. This Schedule does not relate to

(a) pensions payable to persons resident in

(i) territories which before the 15th day of August 1947, were included in India or in Burma, as defined by subsection (1) of Section 311 of the Government of India Act 1935; or

(ii) the Portuguese Settlements or the former French Settlements in India.

(b) pensions payable to any person resident in any place outside the United Kingdom, if the pension is expressed in rupees in Indian Pension Regulations or the corresponding Burma Regulations.

3. A pension to which this Schedule relates may be increased provided the following conditions are fulfilled:

(a) The income of the pensioner does not exceed, in the case of a pensioner who is married or has at least one dependant, £550 a year, or in any other case, £425 a year, including any pension in either case, but disregarding, in assessing income for this purpose, the first £104 a year of income other than the increasable pension or pensions; and

(b) either:—

(i) the pensioner has attained the age of 60 years (or, where the pension is a widow's pension, 40 years) or has not attained the age of 16 years; or

(ii) the pensioner was invalided from the Army or Royal Indian Navy; or

(iii) the pensioner is a woman who has at least one dependent; or

(iv) the pensioner is permanently incapacitated by physical or mental infirmity from engaging in any regular full-time employment.

4. The increase admissible shall be as follows:—

(a) If the pensioner is married, or has at least one dependant, £26 a year, or in the case of pensions assessed at weekly or daily rates, 10s. a week;

(b) In other cases, £20 a year, or in the case of pensions assessed at weekly or daily rates, 7s. 8d. a week; but shall in no case exceed either one-third of the rate of pension (including any increase granted under orders issued by the Governments of India or Burma applying to the Indian or Burma Armed Forces provisions similar to those in Royal Warrants dated 16th August 1920, 7th August 1924, 31st May 1944, 18th January 1946, and 13th May 1947), or the amount required to bring the income of the pensioner up to the appropriate income limit in paragraph 3 (a) above, whichever is less.

5. Any portion of a pension which has been commuted shall not be regarded as part of the pension for the purposes of this Schedule.

6. The income of a married pensioner shall be deemed to include the income of the husband or wife of that pensioner, but with that exception the income of a pensioner shall not be deemed to include the income of any other person.

7. A pensioner shall be regarded as unmarried unless the husband or wife of the pensioner is alive, and where a husband and wife are living apart they may be treated as unmarried persons at the discretion of our Secretary of State.

8. To be regarded as dependent on the pensioner for the purposes of this Schedule a person must be in fact wholly or mainly supported by the pensioner, and must not have an income from other sources (apart from income from any scholarship or educational endowment) in excess of £104 a year, and must be either

(i) the parent, brother, sister, child, uncle or aunt of the pensioner, or of the pensioner's husband or wife, or deceased husband or wife, or the child of such a relative ("child" including legitimate or illegitimate children, step-children, and statutorily adopted children) or the pensioner's step-father or step-mother, or

(ii) under 16 years of age, or receiving full-time instruction at an educational establishment, or undergoing full-time training for a trade, profession or vocation.

9. Where a pensioner is in receipt of more than one pension to which this Schedule relates or under paragraph 10 is deemed to relate, the aggregate of the increases on all such pensions shall be restricted to the increase which would have been given on a single pension equal to their total.

10. For the purpose of paragraph 9 any pension which is payable out of moneys provided by Parliament and which is increasable under the Pensions (Increase) Act, 1952, or under any provision corresponding to the present Warrant shall be taken into account as if it were a pension to which this Schedule relates.

11. Where a widow in receipt of a widow's pension has dependent on her a child or children under 16 years of age receiving pension or compassionate allowance in respect of her husband's service, the widow's pension and children's awards shall be aggregated for the purpose of determining the amount of the admissible increase. The amount so determined shall be distributed proportionately between the awards.

GENERAL PROVISIONS.

12. Any general conditions attaching to the grant or continuance of a pension shall also apply to the grant or continuance of any increase to that pension awarded under this Schedule.

SECOND SCHEDULE.

Application to certain officers of the former Indian Army and Royal Indian Navy and to certain officers who served with the armed forces of Burma, of increases in pension corresponding as near as may be with the benefits provided in

the case of certain civil pensions by the Pensions (Increase) Act 1954.

Any pension increased or further increased under this Schedule to Our Warrant shall as so increased be regarded as the purpose of Our Warrant dated 14th October 1952, or of the First Schedule to this Our Warrant, as if assessed under regulations in force before 1st September 1950.

(1) Except as provided in paragraphs 6 and 7, this Schedule applies to commissioned officers awarded pensions in accordance with the Rules in Pension Regulations India Part I. Pension Regulations for the Royal Indian Navy, or the corresponding regulations of the Government of Burma.

(2) Subject to the provisions of paragraph 3 and 5 of this Schedule, service pensions and the service portion of disability pensions may be increased by ten per cent.

(3) For the purpose of computing the increase under paragraph 2 of this Schedule the following shall be excluded:

(a) Any increase admissible under Rules made by Government of India or Government of Burma, corresponding to those contained in the Warrant of His late Majesty King George VI dated 31st May 1944, as amended by the Warrant dated 13th May 1947.

(b) Any increase under Our Warrant dated 14th October 1952, or under the First Schedule to this Our Warrant.

(c) Where in Pension Regulations India Part I or Pension Regulations for the Royal Indian Navy provision is made for a specific Indian Element—that Indian Element.

(d) Where no specific Indian Element is prescribed in the regulations referred to in sub-paragraph (c)—twenty-five per cent. of pension excluding the elements mentioned in sub-paragraph (a), (b), (e), (f) and (g).

(e) Additional pensions awarded to certain officers of the rank of Lieutenant-Colonel and above of the Indian Medical Service.

(f) Additional pensions awarded to certain officers of the Indian Army under Army Instruction (India) 101 dated 9th September 1930 or 132 dated 29th December 1931.

(g) Special additional pensions awarded under Article 475B of the Civil Service Regulations to Indian Army officers who held high civil posts, and under Rule 40 of Pension Regulations for the Royal Indian Navy to officers of the Royal Indian Navy.

(4) In computing the increase permissible under paragraph 2 of this Schedule, any sum commuted from the original pension shall be added to the existing pension.

(5) Any increase granted under this Schedule shall be reduced by any increase granted by the Government of India or the Government of Burma under Rules corresponding to those included in the Warrants of His late Majesty King George VI dated 31st May 1944 and 13th May 1947.

(6) This Schedule does not relate to pensions payable to persons resident in

(i) territories which before the 15th day of August 1947 were included in India or Burma as defined by sub-section (1) of Section 311 of the Government of India Act, 1935; or

(ii) the Portuguese Settlements or the former French Settlements in India.

(7) This Schedule does not relate to

(a) officers who retired after 19th December 1945, and were pensioned under Army Instruction (India) No. 29 Special dated 30th November 1946 or No. 31 Special dated 16th June 1947;

(b) officers awarded pensions on premature retirement under Army Instruction (India) 43 Special dated 21st July 1947;

(c) officers of the Royal Indian Navy pensioned under Royal Indian Navy Fleet Order No. 54 N.S. dated 27th December 1947;

(d) officers of the Royal Indian Navy awarded pensions on premature retirement in accordance with the compensatory and pensionary terms announced by the Government of India in Joint Defence Council letter dated 15th September 1947 No. P.A./86/A 23/N.H.Q.

THIRD SCHEDULE.

This Schedule specifies the service pensions and ordinary rates of widow' and children's pensions, or the portions of such pensions, payable to the persons referred to in paragraphs (1) to (8) below.

(1) British soldiers who served or are serving on a regular peace-time attestation and who were granted emergency commissions in the Land Forces (Indian Army) or Royal Indian Naval Volunteer Reserve; British soldiers who served on a regular peace-time attestation, were granted emergency commissions in the Departmental Section of the India Unattached List, and at the date of retirement had less than ten years reckonable service on the India Unattached list.

(2) Widows and children of those referred to in (1).

(3) British soldiers who served or are serving on a regular peace-time attestation, were granted emergency commissions in the Land Forces (Indian Army) or Royal Indian Naval Volunteer Reserve, or the Departmental Section of the India Unattached List, and had ten or more years' service on that list including service as emergency commissioned officers.

(4) Widows and children of those referred to in (3).

(5) Departmental Officers of the former India Unattached List granted regular commissions before completing two years' service as regular officers.

(6) The widows and children of regular British officers of the former Indian Armed Forces and the Indian Medical Service; of regular officers and warrant officers of the former India Unattached List; of British officers and warrant officers of the former Royal Indian Navy; and of British officers and soldiers who served with or formed part of the armed forces of Burma before the 4th January 1948.

(7) Officers, warrant officers and soldiers referred to in (6) who after retirement were re-employed during the war of 1939-45 with the armed forces of the United Kingdom or of any other part of the Commonwealth.

The pensions payable under the rules and at the rates prescribed in Section IV of the Schedule to the Warrant of His late Majesty King George VI dated 9th February 1949.

The pensions at ordinary rates as laid down in Article 206 of the Warrant of His late Majesty King George VI for the Pay, Appointment, Promotion and Non-effective Pay of the Army, 1950, under the rules promulgated in Our Warrant dated 12th December 1953.

The difference between the pension determined in accordance with the rules stated in para. (1) and the pension calculated in accordance with the rules in Section IX of the Schedule to the Warrant of His late Majesty King George VI, dated 9th February 1949.

The difference between the pension payable under Our Warrant of the 12th December 1953, and the pension payable under Section XII of the Warrant of His late Majesty King George VI for the Pay, Appointment, Promotion and Non-effective Pay of the Army 1940, together with any increase payable under the Warrant of His late Majesty King George VI, dated 13th May 1947.

The difference between the pension calculated under Section II of the Schedule to the Warrant of His late Majesty King George VI, dated 9th February 1949, and the pension assessed for an emergency commissioned officer under Section IV of the Schedule to that Warrant.

The increase in the ordinary rates of widows' and children's pensions specified in Article 206 of the Warrant of His late Majesty King George VI for the Pay, Appointment, Promotion and Non-effective pay of the Army, 1950, under the rules promulgated in Our Warrant dated 12th December 1953.

The increase in pension resulting from re-assessment in accordance with the provisions of Sections III and XI of the Schedule to the Warrant of His late Majesty King George VI, dated 9th February 1949.

(8) Officers of the former Indian Army who were compulsorily retired under the provisions of Army Instruction (India) No. 132 of 1931 and were re-employed during the war of 1939-45 with the armed forces of the United Kingdom or India; officers who had retired from the Special Unemployed List before the 3rd September 1939, and were similarly re-employed after that date.

(9) The commutation of the pensions or portions of pensions referred to in (1), (3), (5), (7) and (8) of this Schedule shall be made in accordance with the Indian Commutation Rules in force on the 1st April 1955.

FOURTH SCHEDULE.

There shall be applied to British officers and warrant officers of the former Indian Army, Indian Medical Service, Royal Indian Navy, Royal Indian Naval Reserve and Royal Indian Naval Volunteer Reserve, and to certain officers and soldiers who served with or as part of the Armed Forces of Burma prior to the 4th January 1948; to their widows and dependants; to Members of the former Queen Alexandra's Military Nursing Service for India and to Members of the Voluntary Aid Detachments who served in India the following benefits:—

(1) The improvements in disability awards and connected allowances, and in widows' and dependants' pensions and connected allowances, authorised in the following Warrants for members of the corresponding Armed Forces of the United Kingdom:—The Warrants of His late Majesty King George VI dated 30th May 1949 (Articles 16, 22 (5) and (6) only), 28th October 1949 (two Warrants) and 23rd May 1951 (two Warrants), and Our Warrants dated 26th April 1952,

18th July 1952, 28th May 1953, and 8th January 1955 (two Warrants on each date).

In relation to officers and soldiers who served with or as part of the former Armed Forces of Burma the Warrants of His late Majesty King George VI dated 12th April 1946, and 24th May 1949, shall also apply.

(2) Any disability awards and connected allowances and widows' and dependants' pensions and allowances of the officers referred to in (1) of the Third Schedule to this Our Warrant.

(3) The disability award in issue to an officer of the former Army in Burma Reserve of Officers.

(4) The difference between (a) any disability awards and connected allowances and widows' and dependants' pensions and connected allowances of the officers referred to in (3) of the Third Schedule to this Our Warrant and (b) awards calculated at warrant officers' rates under the relevant Indian Regulations.

Civil Service Commission, 14th June 1955

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz. :—

REGULATIONS FOR THE RECRUITMENT OF CARTOGRAPHICAL DRAUGHTSMEN IN THE GEOLOGICAL SURVEY AND MUSEUM UNDER THE DEPARTMENT OF SCIENTIFIC AND INDUSTRIAL RESEARCH.

1. Age.

Candidates must be at least 16 years of age on 1st September 1955. There is no upper age limit.

2. Sex.

(i) Both men and women are eligible.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid. Provided that this the first period of service (including any period of undertaking will not be required if the break between unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions :—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

5. Qualifications.**Candidates must**

(a) have obtained a School Certificate with at least four credits; or the Senior Leaving Certificate awarded by the Scottish Education Department; or

(b) have obtained the General Certificate of Education with passes at Ordinary level in English Language and three other subjects or the Scottish Leaving Certificate with passes on the lower grade in English and three other subjects. Preference will be given to candidates with a pass in Mathematics or Art or Geography or a Science subject; or

(c) produce a statement from the Scottish Education Department that they have attained a standard at least as high as that required under (a) or (b) above; or

(d) have passed an examination accepted by the Commissioners as of an academic standard at least as high as that required under (a) or (b) above.

Exceptionally, candidates without the above qualifications may be admitted if they have at least three years' experience in a cartographic drawing office, including at least one year's service in a Government Department, and provided that a Certificate of Competence is furnished by their Department at the time of their application.

6. Examination.

Candidates who appear from their applications to be suitably qualified (see Regulation 5) will be examined in:—

Candidates must attain in each subject a standard satisfactory to the Commissioners; the final order of merit of the candidates will be determined by their total marks in the two subjects.
