THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Her Majesty has been pleased, by and with the advice of Her Privy Council, to make an Order in Council under Section 1 (1) of the Isle of Man (Customs) Act, 1955, entitled The Isle of Man (Customs) Order, 1955.

This Order confirms a Resolution of the Court of Tynwald held in the Isle of Man on 21st June 1955, and continues for a further period of twelve months until 1st August 1956, duties of customs imposed annually on certain goods removed or imported into the Isle of Man.

The Order comes into operation on the 1st August 1955, and has been published as Statutory Instruments, 1955, No. 1211.

Civil Service Commission, 2nd August, 1955

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE RECRUITMENT OF DRIVING AND TRAFFIC EXAMINERS IN THE MINISTRY OF TRANSPORT AND CIVIL AVIATION.

#### I. Age.

Candidates must have been born on or before 1st July 1925. There is no upper age limit, but in appointing persons in a permanent capacity Departments expect regular and effective service for a reasonable period, and the Comissioners will take this requirement into account.

2. Sex an I Mair'age.

(i) Both men and women may compete under these Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect beto e 15th October 1946, or who are widows or divorced, or who are separated from their hus bands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they find take to refund on appointment the marriage gratuity paid. Povided that this undertaking will not be required if the beak between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) ind the date of re-establishment is more than seven years.

## 3. Nationality.

Candidates must be British subjects They must also satisfy one of the following conditions:

- (a) If natural-born British subjects, they must either
- (i) have at least one parent who is or was at death a British subject; or
- (ii) have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment
- (c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an execption may properly be made in their favour.

## 4. Qualification.

Candidates must have had a wide experience of driving including recent experience; experience in driving motor cycles will be an advantage. Certain motoring offences will lead to disqualification. Candidates must know the
