The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz:

REGULATIONS FOR THE RECRUITMENT OF CIVILIAN CHEF INSTRUCTORS (MFN) UNDER THE WAR OFFICE.

- 1. Men only are eligible.
- 2. Candidates must, on a date to be fixed for each competition, be at least 28 years of age. There is no upper age limit, but Departments expect regular and effective service for a reasonable period, and this requirement will be taken into account.
- 3. Candidates must be natural-born British subjects born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions. No departure from this rule will be made without the special permission of the Secretary of State for War and then only in exceptional cases and in favour of candidates who are British subjects and who also satisfy one of the following conditions:
 - (a) If natural-born British subjects they must either
 - (i) have at least one parent who is or was at the time of death a British subject; or
 - (ii) have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (b) If naturalised British subjects they must have resided in Her Majesty's dominions and/or been employed cleewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Civil Service Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may be made in their favour.

4. Candidates must

- (1) have served a Kitchen Apprenticeship (3 years) in a first-class hotel or attended a full (3 years) course at the Hotel School L.C.C. Westminster Technical Institute or a similar establishment approved by the Ministry ol Education, or be in possession of City and Guilds of London certificate No. 152 (Advanced Cookery Hotels and Restaurants); or have equivalent training;
- (2) have been employed as a Head or Departmental Chef in a large hotel;
- (3) have the personality and ability to instruct students undergoing cookery instruction.
- 5. Those candidates who appear from their applications to have the best qualifications and experience will be required to take a test and will be summoned to interview before a Selection Board which will recommend for the vacancy existing the candidate who seems to be most suitable.
- 6. Any attempt on the part of the candidates to enlist support for their applications through Members of Parliament or other influential persons will disquality them for appointment.
- 7. The necessary number of candidates will be appointed in an unestablished capacity subject to their satisfying the Civil Service Commissioners that they are eligible for appointment in respect of age, nationality, health and character and to the payment of a fee of 10s.
- 8. After a minimum qualifying period of two years' unestablished service in the class Civilian Chef Instructors appointed under these Regulations may be considered for appointment to the established staff as and when vacancies occur thereon, if they are recommended by their Department as qualified in other respects. Those so considered will appear before a final Selection Board set up by the Civil Service Commissioners, which will recommend to the Commissioners the candidates who appear to be qualified
- 9. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a fee of £2 10s. being the balance of the prescribed fee of £3, is payable before the certificate of qualification can be issued.

DISEASES OF ANIMALS ACT, 1950 MINISTRY OF AGRICULTURE, FISHERIES AND FOOD

DEPARTMENT OF AGRICULTURE FOR SCOTLAND

Notice is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture, Fisheries and Food, and the Secretary of State for Scotland acting jointly have made the following Order:

Statutory Instruments 1955 No. 1310

The Animals (Landing from Channel Islands, Isle of Man, Northern Ireland and Republic of Ireland) Order, 1955 (Made 17th August, 1955)

This Order, made under the Diseases of Animals Act, 1950 and coming into operation on 1st September, 1955, reenacts with modification the Animals (Landing from Ireland, Channel Island and Isle of Man) Orders of 1933, made under the Diseases of Animals Acts, 1894 to 1927 (repealed by the Diseases of Animals Act, 1950).

The principal changes are:-

- (i) swine imported from Northern Ireland and the Republic of Ireland which are not intended for immediate slaughter need no longer be accompanied by special declarations in addition to a veterinary certificate;
- (ii) all sheep are now required to be immersed in an approved "single-dipping" type sheep dip before leaving a landing place, save only sheep imported from the Isle of Man and sheep proceeding direct to a slaughterhouse, in which case they must be slaugtered there within six days of arrival;
- (iii) there have been omitted from Part IV of the Order, which regulates the movement from a landing place of sheep, goats and swine, corresponding references to cattle. The movement of imported cattle is now regulated by the Second Schedule to the Diseases of Animals Act, 1950, itself.
