WHEREAS the Royal Institute of Chemistry have duly made variations in the By-laws for the said Institute:

And whereas the said variations have been submitted to the Lords of the Council for allowance:

Now, Therefore, Their Lordships, having taken into consideration the said variations in the By-laws are pleased to allow the same as set forth in the Schedule to this Order.

SCHEDULE

Variations in the By-laws of the Royal Institute of Chemistry referred to in the foregoing Order.

Delete existing By-laws 2, 49, 50, 51, 52, 53, 60, 62, 63, 64 and 91, and the headings to Chapters VI and VII of the By-laws, and substitute the following new By-laws and headings therefor:—

- "2. In these By-laws, unless the context otherwise require:-
 - (a) Expressions referring to the Institute, corporate members. Fellows, Associates, the Council and Meetings of the Institute are to be construed as having reference to The Royal Institute of Chemistry, corporate members, Fellows, Associates, the Council and Meetings of the Royal Institute of Chemistry; provided that the expressions "corporate member" or "corporate members" used in these By-laws shall not relate to any Honorary Fellow unless specifically provided.
 - (b) Expressions referring to non-corporate members are to be construed as having reference to the persons affiliated to the Institute of the grades mentioned in By-law 49.
 - (c) Words defined in the Chapter have the meanings there defined.

"Chapter VI—Admission and Privileges of Non-Corporate Members

- "49. (1) There shall be two classes of persons affiliated to the Institute but not corporate members thereof, namely, Graduate Members constituting the grade of Graduate Membership, and Student Members constituting the grade of Student Membership.
- (2) No person shall be eligible for admission as a non-corporate member unless he is a British subject or a Commonwealth citizen or a citizen of the Republic of Ireland. Provided that citizens of a country, the subjects of which were formerly British subjects or Commonwealth citizens, which has been approved for that purpose by the Institute in General Meeting, may also be eligible for admission.
- (3) Subject to such conditions and regulations as the Council may from time to time prescribe with regard to training and examinations and other matters, the Council may admit to either grade of non-corporate membership any person who is eligible under section (2) of this By-law.
- (4) Every Student of the Institute under the By-laws in force immediately before the making of this By-law shall,

until a day which shall be appointed by the Council, continue as a Student of the Institute and retain such privileges but be subject to such obligations, conditions and provisions in all respects as he would have had or would have been subject to if such By-laws had continued in force until the day so appointed, and every power of making regulations under such By-laws shall continue to exist until that day.

- "50. (1) Every non-corporate member who is not in arrear with the payment of his annual subscription shall be entitled to attend the Meetings of the Institute other than Annual and Special General Meetings and to such other privileges as the Council may from time to time grant to members in each grade, of non-corporate membership.
- (2) A non-corporate member shall not be entitled to vote at any Meeting.
- "51. (1) The Registrar (or other specified Administrative Officer) shall keep a Register of non-corporate members containing separate lists of the names of Graduate Members and Student Members, with their dates of admission and addresses and such other particulars as may from time to time be prescribed by the Council.
- (2) The Registrar (or other specified Administrative Officer) shall cause to be entered in the Register any change of address of any non-corporate member of which notice has been given to him by such member.
- "52. (1) In as much as membership of a non-corporate grade is intended only for those preparing for admission to corporate membership the membership of any Student Member who has not qualified for and applied for admission to Graduate Membership or of any Graduate Member who has not qualified for and applied for admission to Associateship within such respective periods of time as the Council may prescribe may be terminated by the Council with effect from the thirty-first day of December in any year.
- (2) The Council in their discretion may at any time, and without assigning any reason therefor, terminate the membership of any non-corporate member if in their opinion it is inadvisable that he should continue to be a non-corporate member of the Institute.
- (3) When any non-corporate member is notified by letter, sent to his registered address, of the removal of his name from the Register he shall, as at the date specified in such letter, cease to be a non-corporate member and to be entitled to any of the privileges thereof.

"CHAPTER VII—Examinations and other Forms of Assessment

- "53. In order to promote the objects of the Charter and more specifically to fulfil the obligations imposed by clause 3 thereof, the Council shall make such provisions as they think fit, by the holding of examinations or otherwise, for the purpose of assessing the adequacy of the training, qualifications, knowledge, skill and experience of candidates for admission to any grade of corporate or non-corporate membership and for the purpose of awarding any certificates or diplomas in special branches or applications of chemistry that may from time to time be authorised; and the Council shall prepare and publish such regulations for these purposes as they think fit, and shall determine the fees, if any, which shall be paid or deposited by candidates in respect of such examinations or other forms of assessment including the assessment of claims for exemption from any examination or part of any examination; and the Council may from time to time as they think fit rescind, vary or add to any of the said regulations.
- "60. (1) All Annual Subscriptions payable under the Charter or these By-laws shall be payable on the first day of January in each year, provided that
- (a) a person who is not already a corporate or non-corporate member shall on application for admission to any grade of corporate or non-corporate membership deposit a sum equal to the Annual Subscription that would have been payable by him if he had been a member in that grade on the first day of January in the year in which he makes such application, which sum shall on his admission be taken in discharge of his liability for payment of any Annual Subscription until after the thirty-first day of December in the year in which he is admitted or, if such admission takes place after the thirtieth day of September in any year, until after the thirty-first day of December in the next succeeding year;
- (b) if at any time during a year a non-corporate or corporate member be admitted to a higher grade of non-corporate or corporate membership or a non-corporate member be admitted to corporate membership, he shall not be required to pay in respect of that year any Annual Subscription other than that applicable to his grade of membership on the first day of January in that year.

- (2) The Council may terminate or suspend the liability of any corporate member to pay further Annual Subscriptions after reaching such age and or after payment of such number of Annual Subscriptions as the Council may from time to time prescribe.
- "62. (1) The Annual Subscription of an Associate shall be such sum, not exceeding Eight Guineas, as shall on the recommendation of the Council be determined from time to time by a General Meeting.
- (2) The Council may receive a Life Subscription from any Associate who has reached such age and or paid such number of Annual Subscriptions as the Council may from time to time prescribe. Provided that such Life Subscription shall be a sum equal to that which would have been payable by him as a Life Subscription if he had been a Fellow at the time of payment, and thereupon the liability to pay an Annual Subscription shall cease irrespective of whether he remains an Associate or subsequently becomes a Fellow.
- "63. The Annual Subscription of a Graduate Member shall be such sum not exceeding Six Guineas, and that of a Student Member such sum not exceeding Three Guineas, as shall be determined from time to time by regulation to be made by the Council.
- "64. The Council shall prescribe from time to time the Entrance Fee, if any, which (in addition to such other fees and subscriptions as may be due under these By-laws) is to be deposited on application for admission, or paid on admission, to each grade of corporate membership (other than that of an Honorary Fellow). Provided that the amount of such Entrance Fee in respect of each such grade shall not exceed Twenty Guineas.
- "91. A non-corporate member shall be deemed to be attached to the Local Section (if any) within the area of which his registered address is situate, and any non-corporate member so attached, and who is not in arrear with the payment of his Annual Subscription, shall be entitled to attend such Meetings of the Section as the Committee of the Section may decide, and shall have such other privileges as that Committee may from time to time grant, but he shall not be entitled to vote at any Meeting thereof."

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE RECRUITMENT OF OFFICERS OF CUSTOMS AND EXCISE IN THE CUSTOMS AND EXCISE DEPARTMENT.

1. No candidate may compete more than twice for the situation of Officer of Customs and Excise.

2. Age.

Candidates must be at least 19 and under 21 years of age on 1st September 1955. But—

- (a) a candidate who has served or is serving in H.M. Forces may deduct from his actual age the period of such service rendered before 1st September 1955;
- (b) a candidate who has served in any established post to which he was admitted with the Certificate of the Civil Service Commissioners may deduct from his actual age any time not exceeding two years which he has spent in such service before 1st September 1955.

3. Sex.

Men only are eligible.

4. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

- (a) If natural-born British subjects, they must either:
- (i) have at least one parent who is, or was at death, a British subject; or
- (ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

5. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

7. Candidates Trained as Teachers.

8. Fee.
