THE Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

RECRUITMENT OF CIVILIAN INSTRUCTIONAL OFFICERS (MEN AND WOMEN) IN THE PRISON SERVICE (ENGLAND AND WALES).

- 1. Candidates must, on a date to be fixed for each competition be
 - (a) in the case of men-at least 30 years of age; and
 - (b) in the case of women—at least 25 years of age.

There is no upper age limit, but Departments expect regular and effective service for a reasonable period, and this requirement will be taken into account.

- 2. Married women who have formerly been established 2. Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who compulsorily resigned on marriage and whose resignation took effect before 15th October, 1946, or who are widowed or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible for appointment to the established staff unless they undertake to refund on appointment the marriage gratuity paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

 3. Candidates must be British subjects. They must also
- 3. Candidates must be British subjects. They must also satisfy one of the following conditions:—
 - (a) If natural-born British subjects, they must either
 - (i) have at least one parent who is or was at the time of death a British subject; or
 - (ii) have resided in Her Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

- (c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Civil Service Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.
- 4. Candidates must be (a) experienced and fully-skilled in their particular trade, craft or subject, (b) able to teach their trade, craft or subject, and (c) able to supervise the work and maintain control, of trainees engaged in their trade craft or subject.

Candidates should have undergone the training usual in their particular trade, craft or subject, followed by practical experience on fully-skilled work for a reasonable number of years (normally not less than five years in a craft trade). These provisions may be waived only exceptionally for individual candidates whose training in the trade, craft or subject and practical experience are comparable to the qualifications normally required. It is desirable for candidates for posts in Grade III to be in possession of an Ordinary National Certificate or City and Guilds Certificate or equivalent qualifications in the appropriate subject where such qualifications exist.

- 5. Those candidates who appear from their applications to have the best qualifications and experience will be summoned for interview before a Selection Board which will recommend for the vacancy existing the candidate who seems to be most suitable.
- 6. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment.
- 7. The necessary number of candidates will be appointed in an unestablished capacity subject to their satisfying the Civil Service Commissioners that they are eligible for appointment in respect of age, nationality, health and character, and to the payment of a fee of 5s.
- 8. After a minimum qualifying period of two years' unestablished service in the grade Civilian Instructional Officers appointed under these Regulations may be considered for appointment to the established staff as and when vacancies occur thereon, if they are recommended by their Department as qualified in other respects. Those so considered will appear before a final Selection Board set up by the Civil Service Commissioners, which will recommend to the Commissioners the candidates who appear to be qualified.

Exceptionally, appointment to the established staff may be considered within the first year of service in order to permit integration of previous superannuable service with the civil service. Candidates recommended under this provision may be required to appear before a final Selection Board set up by the Civil Service Commissioners.

9. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a further fee as follows is payable before the certificate of qualification can be issued:—

Grades III and IV 15s., being the balance of the prescribed fee of £1.

Grade V 10s., being the balance of the prescribed fee of 15s.

REGULATIONS FOR THE RECRUITMENT OF ASSISTANTS (SCIENTIFIC) IN VARIOUS GOVERNMENT DEPARTMENTS.

Candidates must be at least $17\frac{1}{2}$ and under 26 years of age on 1st January, 1956. But

- (a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct from his actual age the period of such service rendered before 1st January, 1956.
- (b) for a certain number of wacancies, candidates born on or before 1st January, 1930, who have specialised experience may be admitted. There is no upper age limit, but in appointing persons in a permanent capacity Departments expect regular and effective service for a reasonable period, and the Commissioners will take this tequirement into account.

- 2. Sex and Marriage.
 - (i) Both men and women may compete under these Regulations.
 - (ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity raid.

Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

- (a) If natural-born British subjects, they must either
- (i) have at least one parent who is or was at death a British subject; or
- (ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office, Air Ministry or Ministry of Supply, unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he or she may be admitted to competition or appointment by special permission of the First Lord of the Admiralty, Secretary of State for War, Secretary of State for Air, or Minister of Supply, as the case may be.

4. Educational Qualifications.

Every candidate must, on the date he sends in his application, be in possession of one of the undermentioned qualifications:—

(a) A School Certificate with credit in mathematics or a science subject obtained by passing an examination conducted by one of the recognised Examining Bodies.

In place of a School Certificate a candidate may produce evidence of having passed the Matriculation Examination of London University or any other examination which in the opinion of the Civil Service Commissioners is of equivalent or higher standard, or

- (b) A General Certificate of Education in four subjects at Ordinary level to include (a) English Language and (b) a scientific or a mathematical subject, or
- (c) The Scottish Leaving Certificate in four subjects on the lower grade which include English and a scientific or mathematical subject, or
- (d) The Senior Certificate of the Ministry of Education for Northern Ireland showing passes in four subjects including English Language and one of the following:—Mathematics (Traditional), Mathematics (Alternative). Physics, Chemistry, Botany, Biology, or
- (e) A statement from the Scottish Education Department or the Ministry of Education for Northern Ireland showing that the candidate has attained a standard equivalent to that represented by the award of the School Certificate of the Oxford and Cambridge Schools Examination Board, including the special qualification in mathematics or a science subject, or by the General Certificate of Education in four subjects at Ordinary level including English Language and a scientific for mathematical subject, or

(f) The Ordinary National Certificate or,

(The Commissioners may admit as eligible under this paragraph candidates who have satisfactorily completed the second year (s 2) of the Senior course.)

- g) The Intermediate Examination of the Institute of Medical Laboratory Technology, or
- (h) An Intermediate Grouped Course Certificate of the City and Guilds of London Institute in Telecommunications, Metallurgy or Laboratory Technicians' Work, or
 - (j) A pass in either

the Forces Preliminary Examination with a pass in either mathematics or natural science, or

the Royal Air Force Higher Education Test, Part I, with a pass in mathematics, mechanics or the pro-perties of matter, or the Admiralty Higher Educational Test, Second

Class, with a pass in mathematics or mechanics or magnetism and electricity, but

- (k) The Commissioners may also accept as eligible candidates who are unable to comply with the requirements above but who
 - (i) have been employed on Assistant (Scientific) duties for a considerable time, have demonstrated their aptitude for this kind of work and are certified by their Department as being worthy of special consideration,
 - (ii) have served for at least 10 years, on a regular (including a regular short-service) engagement, in the technical branch of H.M. Forces. Such candidates must have served an artificer apprenticeship (where appropriate) or have reached the rank of Petty Officer or Sergeant, or
 - (iii) are employed full-time as glass-blowers in Government Departments, provided they are nominated by their Department and satisfy the Commissioners of their skill in their craft. Such candidates must be wholly employed in the construction of glassware for use in scientific laboratories. scientific laboratories.

Every candidate must have had thorough experience in the duties of the class gained by service in a Government Department or other civilian scientific establishment or in technical branches of the Forces. The experience must cover a minimum period of two years to be completed before the date on which he sends in his application, on duties appropriate to the type of vacancy for which application is made and the two-year period must be recent, subject to allowance for gaps in cases where the experience has been broken by service in H.M. Forces.

6. Competition.

- (i) The Commissioners may, at their discretion, summon candidates to preliminary informal interview.
- (ii) The Commissioners may, at their discretion, impose a practical or other relevant test upon candidates, or groups of candidates, as seems appropriate.
- (iii) Those candidates whose qualifications and experience seem most suitable will be summoned to appear before a Selection Board appointed by the Commissioners. The Board will take into consideration the candidates' record of may receive from persons named by the candidates as having direct knowledge of their work in the past, and the candidates' scientific knowledge and personal qualities as shown at the preliminary interview, the practical or other test imposed, and at the final interview; and on their estimation of all the above evidence the Board will frame their recommendations.
 - (iv) The decision of the Commissioners will be final.
- 7. A candidate may make one and only one application under these Regulations during the year.

8. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

9. Candidates trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

10. Assignment.

It will rest with the Commissioners to determine the Department to which each successful candidate shall be assigned. In making the assignments the Commissioners will be guided by the requirements of the public service but the wishes of candidates will be met as far as possible.

11. Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

12. Fee.

Every successful candidate will be required to pay a fee of £1 before the issue of a certificate of qualification for appointment.
