The QUEEN has been pleased to issue a Warrant under Her Majesty's Royal Sign Manual to the following effect:—

ELIZABETH R.

ELIZABETH THE SECOND, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories QUEEN, Head of the Commonwealth, Defender of the Faith, to all to whom these Presents shall come,

Greeting!

Whereas His late Majesty King George the Fifth in consideration of the faithful and devoted service rendered by members of the Special Constabulary during the Great War, 1914-18, and being desirous of distinguishing such service by some mark of His Royal Favour, and also of providing a means of recognizing continued and efficient service which might be rendered in the future by members of any Special Constabulary Reserve thereafter constituted, did by Warrant under His Royal Sign Manual dated the 30th August, 1919, institute and create a new Medal to be awarded for such service as aforesaid:

And whereas by Warrants under the Royal Sign Manual of His late Majesty King George the Fifth dated the 31st January, 1920, the 15th August, 1929, and the 1st October, 1930, respectively, and the Royal Sign Manual of His late Majesty King George the Sixth dated the 23rd January, 1937, the 22nd June, 1940, the 27th December, 1945, the 15th July, 1950, and Our Royal Sign Manual dated 31st December, 1952, respectively, revised Rules were established for the governance of the said Decoration:

And whereas We are desirous of further amending

the said Rules, We are graciously pleased to make, ordain and establish the following Rules for the governance of the said Decoration:—

I. It is ordained that the Medal shall be designated and styled "The Special Constabulary Long Service Medal."

II. It is ordained that the Medal shall consist of a circular Medal of Bronze with the Effigy of the Sovereign on the obverse and on the reverse an appropriate design or inscription, and shall bear on the rim the name of the person to whom the Medal is awarded.

III. It is ordained that the Medal shall only be awarded to those of Our faithful subjects who, being or having been members of the Special Constabulary, shall satisfy the following conditions, namely:

(1) Shall have served as a Special Constable without pay during the Great War 1914-18 for not less than three years, and shall during that period have performed not less than 150 police duties: or

(2) Shall have served as a Special Constable without pay for a period of not less than nine years or for periods amounting in the aggregate to not less than nine years, and shall be recommended by the Chief Officer of Police as willing and competent to discharge the duties of a Special Constable and as having performed without pay such duty as a Special Constable as has been required from him by the Chief Officer of Police during that period or those periods.

Provided that each period of such service without pay during the Great War 1914-1918 or during the period beginning with the 3rd September, 1939, and ending with the 31st December, 1945, amounting to one year or upwards in the course of which the Special Constable completed not less than 50 police duties shall be reckoned as equivalent to three years' efficient service under condition (2), and other periods in the same proportion: or

(3) Shall have served as a member of the Ulster Special Constabulary for a period of not less than fifteen years or periods amounting in the aggregate to not less than fifteen years, and shall be recommended by the Inspector-General, Royal Ulster Constabulary, as willing and competent to discharge the duties of a member of the Ulster Special Constabulary and as having performed such duty as a Special Constable as had been required of him by the Inspector-General during that period or those periods.

IV. It is ordained that the Medal shall be awarded by Our Secretary of State for the Home Department or by Our Secretary of State for Scotland or by Our Minister of Home Affairs for Northern Ireland, and that the names of the persons eligible for such Medal shall be submitted to Our said Secretaries of State or Minister respectively by the Chief Officer of Police or Inspector-General, Royal Ulster Constabulary, under whom such persons have served.

V. It is ordained that the Medal shall be worn on the left breast suspended from a riband of an inch and three-eighths in width, of which the central part (one-third of the whole) shall be red, while the remaining parts shall each have three longitudinal stripes of equal width, the central stripe being black and the other two white; and further, that in the case of those to whom the Medal is awarded for service during the Great War 1914-1918 a bar or clasp shall be attached to the riband, bearing the words "The Great War. 1914-1918."

VI. It is ordained that an additional bar or clasp which shall be attached to the riband and shall bear upon it the words "Long Service" may be awarded to those to whom the Medal has been awarded upon the same recommendation by the Chief Officer of Police or Inspector-General as is required for the award of the Medal upon the completion of each ten years of service after the completion of qualifying service for the Medal, or, where such award was made under Rule III (1), after 19th July, 1919, and for each Bar awarded a small silver rose shall be added to the riband when worn alone. Provided that each period of service without pay during the period beginning with the 3rd September, 1939, and ending with the 31st December, 1945, amounting to one year or upwards in the course of which the Special Constable completed not less than 50 police duties shall be reckoned as equivalent to three years service for the purpose of this Rule and other periods in the same proportion.

VII. It is ordained that on a recommendation to that effect by or through one of Our said Secretaries of State or Our said Minister it shall be competent for Us, Our Heirs, and Successors to direct the cancellation and annulment of the award to any person of the Medal or Bars, and thereupon the name of such person shall be erased from the record of those to whom the Medal shall have been awarded, and every person whose Medal shall be so forfeited shall on being required so to do by either of Our said Secretaries of State or Our said Minister deliver up his Medal to such person as either of Our said Secretaries of State or Our said Minister may direct. Provided that it shall be competent for Us, Our Heirs and Successors to direct the restoration of any Medal or Bars which may have been so forfeited when such recommendation has been withdrawn.

VIII. All previous Warrants issued in this behalf are hereby revoked except in so far as they are already revoked.

TENDERS FOR TREASURY BILLS.

1. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

CONDORRAT IMPROVEMENTS

The Minister of Transport and Civil Aviation hereby give notice that he proposes to make two Orders under Section 14 of the Special Roads Act, 1949, the effect of which will be:—

- to provide for the re-alignment and regrading of that part of Orchardton Road, Condorrat, which lies immediately to the west of the line of the Condorrat Diversion and of that part of North Road, Condorrat, (B.802) which lies upon or immediately adjacent to the line of the Condorrat Diversion;
- to provide for the construction by the Minister of a new road from a point on the present Gretna-Stranraer-Glasgow-Stirling Trunk Road approximately 150 yards south west of its junction with Orchardton Road for a distance of approximately 37 yards in a westerly direction to link up with the Condorrat Diversion;

The Foot-and-Mouth Disease (Infected and Controlled Areas Restriction) (Amendment) Order, 1956

This Order, which comes into operation on 1st March, 1956, abolishes the need for counter-signature of licences authorising the movement of animals into and within Foot-and-Mouth Disease Infected and Controlled Areas. It also prohibits the holding of point-to-point meetings in Infected Areas, and permits greyhound racing to take place in Infected Areas on tracks licensed under the Betting and Lotteries Act, 1934.
