Know ye that We do hereby by virtue of the provisions of the said Acts except from among the number of Counsellors of State during the period of Our absence Our Husband Prince Philip Duke of Edinburgh and delegate for that period to the following Counsellors of State that is to say to Queen Elizabeth the Queen Mother Princess Margaret The Duke of Gloucester The Duke of Kent and the Princess Royal the Royal functions hereinafter specified to be exercised jointly by not less than two of their number subject to the condition that if We signify or it appears to them that they should not act in any matter or for any purpose without Our previous special approval they shall not act in that matter or for that purpose without that approval and accordingly We do by these Presents delegate to the said Counsellors of State or any two or more of them full power and authority during the period of Our said absence to summon and hold on Our behalf Our Privy Council and to signify thereat Our approval of anything for which Our approval in Council is required and further to approve and sign on Our behalf commissions for signifying the Royal Assent to Acts of Parliament except an Act touching any of the matters for which provision is made in the Act of Settlement or touching Our Royal Style and Titles and to approve and sign on Our behalf any proclama ion warrant fiat submission or other document requiring Our approval or Signature which relates to the affairs of Our United Kingdom or to the affairs of any of Our Colonies or any Territories under Our protection or in which We have jurisdiction in cases where Our Government in the United Kingdom is responsible for the foreign affairs of such Colonies or Territories and to do on Our behalf anything required to be done in relation to any such proclamation warrant fiat st bmission or other document and further to do on Our behalf anything which by virtue of Our Royal Prerogative or of any statutory of other power we are authorised to do for the safety or good government of Our United

The Hydrocarbon Oil Duties (Drawback) (No. 1) Order, 1957.

This Order consolidates, with the changes mentioned below, the Orders referred to in the Third Schedule, which provide for the allowance of drawback of customs or excise duty paid in respect of hydrocarbon oil used in the manufacture or preparation of certain classes or descriptions of articles.

The Order reduces the rates used for determining the quantities of hydrocarbon oil in respect of which drawback is allowed as respects the classes or descriptions of articles specified in paragraphs 2 and 5 of the First Schedule.

The Order also provides for the allowance of drawback, at the rate specified in paragraph 3 (a) of the First Schedule, in respect of hydrocarbon oil used in the manufacture or preparation of industrial adhesive tapes of any material. Formerly the drawback in respect of industrial adhesive tapes was allowable at a slightly higher rate but was allowable only as respects tapes made of cloth, proofed cloth paper or cellulose.

The changes apply in respect of articles which are exported, or shipped or deposited in warehouse for use as stores, on or after 21st May, 1957.

The Order comes into operation on the 21st May, 1957, and has been published as Statutory Instruments 1957, No. 823.

Statutory Instruments 1957 No. 787. The Live Poultry (Restrictions) Order, 1957 (Made 6th May, 1957)

This Order, which comes into operation on 20th May. 1957, revokes and re-enacts the Live Poultry (Restrictions) Order, 1954 (as amended), with some alterations. The principal changes are:—

- (1) The prohibition of the movement of poultry from any part of Great Britain into an area comprising Wales, the Scilly Isles and certain Northern, West Midland and South Western counties of England is withdrawn. This withdrawal leaves intact the prohibition of the movement of poultry, day-old chicks or hatching eggs into Scotland from any other part of Great Britain.
- (2) Poultry exhibitions and shows held in England and Wales are required to be licensed by the local authority but that provision of the Poultry Pens, Fittings and

Receptacles (Disinfection) Order, 1952, S.I. 1952/437 (1952 III, p, 2628), that requires notice of the intention to hold such an exhibition or show will no longer apply in England and Wales.

- (3) The provision of Part I of the Order (prohibiting the holding of sales of poultry and day-old chicks, and certain movements of poultry) are extended to the Scilly Isles, subject to the same exceptions and licensing provisions as are applicable to the rest of England and Wales.
- (4) Licenses to hold sales of poultry in England and Wales may in future be granted by local authorities only for sales by auction.
