### Civil Service Commission,

2nd August, 1957. The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:--

REGULATIONS FOR THE RECRUITMENT TO THE BASIC GRADE OF CIVIL ENGINEERS AND STRUCTURAL ENGINEERS.

1. Both men and women may compete under these Regulations, except that women will not be eligible for appointments under the Admiralty, War Department or Air Ministry.

2. Age.

Candidates must be at least 25 and under 35 years of age on 1st January, 1957. But

(1) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct from his actual age the period of such service rendered before 1st January, 1957;

(2) candidates who have served in any established post to which they were admitted with the Certificate of the Civil Service Commissioners, or who have served on established conditions except for sick leave and pension in a post to which such a certificate would normally apply, may deduct from their actual age any time not exceeding two years which they have spent in such service before lst January, 1957;

(3) candidates over the age of 34 will be admitted to the competition if they have served in Government Departments as temporary Civil Engineers or Structural Engineers (as the case may be) for at least two years continuously up to their date of application.

### 3. Nationality.

(1) To be eligible for appointment (other than to a situation in the Admiralty, War Office or Air Ministry) a candidate must be a British subject, a British protected person or a citizen of the Irish Republic and in addition satisfy one of the following conditions:—

(a) if he was a British subject, a British protected perton or a citizen of the Irish Republic at birth—

- (i) at least one of his parents must be, or have been at death, a British subject, a British protected person or a citizen of the Irish Republic, or
- (ii) the candidate must have resided in a country or territory within the Commonwealth or in the Irish Republic or been employed elsewhere in the service of the Crown or partly have so resided and partly been so employed for at least five years out of the last eight years preceding the date of his appointment:

(b) if he was not a British subject, a British protected person or a citizen of the Irish Republic at birth. he must have resided in a country or territory within the Commonwealth or in the Irish Republic or been employed elsewhere in the service of the Crown or partly have so resided and partly been so employed for at least five years out of the last eight years preceding the date of his appointment:

(c) if not qualified under sub-paragraph (a) or subparagraph (b) of this paragraph, he must satisfy the Commissioners that he is so closely connected with a country or territory within the Commonwealth either by ancestry. upbringing or residence, or by reason of national service, that an exception may properly be made in his favour.

(2) a candidate will not be eligible for appointment to a situation in the Admiralty, War Office or Air Ministry nless (i) at all times since his birth he has been either a Brush subject or a cifizen of the Irish Republic and (ii) he was born in a country or territory which is (or then was) when the Commonwealth or in the Irish Republic and (iii) each of his parents was born in a country or territory which is (or then was) within the Commonwealth or in the Irish Republic and (iii) each of the Jrish Republic and a been one or be other at all times from birth:

Provided that, notwithstanding that the aforesaid conditions are not satisfied, he may, if the conditions specified in paragraph (1) of this Regulation are satisfied, be admitted to appointment by special permission of the First Lord of the Admiralty, the Secretary of State for War, or the Secretary of State for Air, as the case may be.

### 4. Qualifications.

A candidate who is taking before the closing date for which an examination necessary to qualify for admistion to the competition will be admitted before the result of the examination is known. He will not, however, be declared successful unless on the result of the examination he obtains the requisite qualification.

All candidates should possess professional ability. Normally this should be supported by evidence of appropriate professional experience in private or outside practice or in the service of a Local Authority or Government Department. In all cases the candidate's professional ability will need to be effectively demonstrated within the period of probation (or corresponding period of trial).

At the time of application (subject to the above proviso) candidates must either

(1) Civil Engineers (a) have achieved Corporate Membership of the Institution of Civil Engineers, or

(b) have passed either :---

(1) Parts I and II of the Institution examination of the Institution of Civil Engineers, or

(2) an examination recognised by that Institution as granting exemption from Parts I and II.

Candidates admitted under (b) will not have their appointments confirmed unless they attain corporate membership under (a) within the'r probation period (or the corresponding period of trial).

For posts in the Ministry of Agriculture, Fisheries and Food candidates must have qualified in the subject Hydraulics.

For posts in the Ministry of Transport and Civil Aviation experience in road and bridge construction is essential and a knowledge of Highway Authorities' procedure or experience with road contractors is desirable.

For posts in the War Department a knowledge of steelwork and reinforced concrete design is desirable.

(2) Structural Engineers (a) have achieved Corporate Membership of the Institution of Civil Engineers, having qualified in the subjects covered by Groups 1 or IV, or

(b) have achieved Corporate Membership of the Institution of Structural Engineers, or

(c) have passed either : ---

(1) Parts I and II of the Institution examination of the Institution of Civil Engineers, having qualified in subjects covered by Groups I or IV in Part II, or

(2) an examination recognised by that Institution as granting exemption from Parts I and II, having qualified in subjects covered by Groups I or IV in Part II, or (d) have passed either:

(1) the whole of the examination for Associate Membership of the Institution of Structural Engineers, or

(2) an examination recognised by that Institution as granting exemption, from its Associate Membership examination, having qualified in subjects covered by the Institution's examination.

Candidates admitted under (c) or (d) will not have their appointments confirmed unless they attain Corporate Membership of the Institution of Civil Engineers or the Institution of Structural Engineers within their probation period or the corresponding period of trial.

### 5. Competition.

Those candidates who on the evidence of the application forms, and any further information which the Commissioners think necessary to obtain, are found to be *prima facie* eligible, will be summoned to a Selection Board. The Commissioners may, if they see fit, summon only those candidates who by reason of their experience and qualifications appear to be most suitable for appointment. The same Selection Board may consider a candidate at one interview for one or more of the classes. The Selection Boards will take into "consideration the candidates' record of experience and training, any recommendations from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview. The decision of the Commissioners will be final, and will be announced separately for the separate classes.

### 6. Application.

Only one application may be made for the competition governed by these regulations.

### 7. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

### 8. Assignment.

The Commissioners will decide to which Department each successful candidate is to be assigned. Assignment will be made in accordance with the needs of the public service but the candidates preference, as stated on his application form, will be taken into account as far as possible.

### 9. Refund of Marriage Gratuity.

Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widowed or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

### 10. Candidates Trained as Teachers.

Persons who have been trained as teachers, elsewhere than in England and Wales, and upon whose training public money has been spent, cannot be appointed until the consent of the Appropriate education authority (e.g., the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

### 11. Canvassing.

Any attempt on the part of candidates to enlist support for their application through Members of Parliament or other influential persons, except as referees to be named in their application forms, will discualify them for appoint ment.

### 12. Fee.

A successful candidate will be required to pay a fee of £4 before the issue of a Certificate of Qualification for appointment.
