TRUNK ROADS ACT, 1946

SPECIAL ROADS ACT, 1949

THE Secretary of State hereby gives notice that he has made an Order under section 1 of the Trunk Roads Act, 1946, as extended by section 14 of the Special Roads Act, 1949, and as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, which provides for:

(a) the following roads in the County of Stirling becoming trunk roads on the date when the Order comes into operation—

(i) a new road which he proposes to construct, by-passing Denny and Dunipace and Dennyloanhead;

(ii) a short length of new road which he proposes to construct, near Haggs;

(iii) 822 yards or thereby of the Kilsyth-Falkirk road (A.803) at Longcroft:

(b) those lengths of the Gretna-Stranraer-Glasgow-Stirling Trunk Road which will be superseded by the new roads, ceasing to be trunk roads on the 16th day of May next after the date on which notice is given by the Secretary of State to Stirling County Council (who will thereafter become the highway authority responsible for that length) that the new roads are open for through traffic:

(c) the construction by the Secretary of State of a bridge over the navigable waters of the Forth and Clyde Canal.

Copies of the Order and of the plan referred to therein have been deposited at the Scottish Home Department, Bankhead Avenue, Sighthill, Edinburgh, 11, and at the offices of the Stirling County Council, County Offices, Viewforth, Stirling, and may be seen at all reasonable hours.

Any Person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Trunk Roads Act, 1946, as amended by the Special Roads Act, 1949, and as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, or on the ground that any requirement of the Trunk Roads Act, 1946, as so amended, and as so read, has not been complied with in relation to the Order, may, within six weeks of the

eighteenth day of October, 1957, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

MERCHANDISE MARKS ACT, 1926

MARKING OF IMPORTED REFRACTORY BRICKS,
BLOCKS AND TILES

THE Board of Trade announce changes to part of the provisions of the Merchandise Marks Order affecting the marking of certain imported refractory bricks, blocks and tiles.

The changes are in respect of imported refractory bricks, blocks and tiles other than metallic bricks, blocks and tiles and refractory bricks, blocks and tiles cast from molten material. From September 17, 1957 such goods may be marked with an indication of origin by stencilling or painting in a contrasting colour either on each brick, block or tile, or (when the goods are imported or subsequently sold in containers) on the outside of the container.

These changes are affected by the Direction made by the Board of Trade under the authority of Section 3 (1) of the Merchandise Marks Act, 1926. The Direction modifies the Merchandise Marks (Imported Goods) No. 4 Order, 1930 (S.R. & O. 1930 No. 527) as amended by the Merchandise Marks (Imported Goods) No. 4 Order, 1930 (Amendment Order), 1937, (S.R. & O. 1937 No. 720). The Direction is entitled the Merchandise Marks (Imported Goods) No. 4 Order, 1930 (Provisional Exemption) Direction, 1957, (S.I. 1957 No. 1641) and can be obtained from H.M. Stationery Office, Kingsway, London, W.C.2, and branches, price 3d. net (by post 5d. net).

The Direction affords temporary relief only. The question whether this relief should be continued by an amendment to the Order in question is being referred to the Standing Committee appointed by the Board under Section 4 of the Act.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

RECRUITMENT FROM UNIVERSITY GRADUATES TO THE EXECUTIVE CLASS OF THE HOME CIVIL SERVICE AND GRADE 5 POSTS IN BRANCH B OF THE FOREIGN SERVICE.

1. No candidate may compete more than twice in the annual competitions for recruitment to the Executive Class from university graduates.

2. The competition is open to men and women, but

(a) women will not ordinarily be appointed to posts in the Admiralty or War Office or to the Immigration Service of the Home Office;

(b) married women are not eligible for appointment to Branch B of the Foreign Service;

(c) the approval of the Secretary of State for Foreign Affairs is required before a married man takes up a Foreign Service appointment.

3. *Age.*

Candidates must be at least 20½ and under 24 years of age on the 1st August, 1958; but a candidate who has served or is serving in H.M. Forces may deduct from his actual age the period of such service rendered before the 1st August, 1958.

4. *Nationality.*

(1) To be eligible for appointment (other than to a situation in the Foreign Service) a candidate must be a British subject, a British protected person or a citizen of the Irish Republic and in addition satisfy one of the following conditions:—

(a) if he was a British subject, a British protected person or a citizen of the Irish Republic at birth—

(i) at least one of his parents must be, or have been at death, a British subject, a British protected person or a citizen of the Irish Republic, or

(ii) the candidate must have resided in a country or territory within the Commonwealth or in the Irish Republic or been employed elsewhere in the service of the Crown or partly have so resided and partly been so employed for at least five years out of the last eight years preceding the date of his appointment:

(b) if he was not a British subject, a British protected person or a citizen of the Irish Republic at birth, he must have resided in a country or territory within the Commonwealth or in the Irish Republic or been employed elsewhere in the service of the Crown or partly have so resided and partly been so employed for at least five years out of the last eight years preceding the date of his appointment.

(c) if not qualified under sub-paragraph (a) or sub-paragraph (b) of this paragraph, he must satisfy the Commissioners that he is so closely connected with a country or territory within the Commonwealth either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his favour.

(2) A candidate will not be eligible for appointment to a situation in the Foreign Service unless at all times since his birth he has been either a British subject or a citizen of the Irish Republic and was born of parents each of whom is or was at death a British subject or a citizen of the Irish Republic and has or had been one or the other at all times since birth:

Provided that, notwithstanding that the aforesaid conditions are not satisfied, he may, by special permission of the Secretary of State for Foreign Affairs, be admitted to appointment if—

(i) he has at all times since his birth been either a British subject or a citizen of the Irish Republic, and

(ii) his father is or was at death a British subject or a citizen of the Irish Republic and has or had been one or the other at all times from birth, and

(iii) he satisfies the Secretary of State that he is so closely connected with a country or territory within the Commonwealth either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his favour.

5. *Education.*

Candidates must have, or obtain in 1958, a University degree.

6. *Health and Character.*

Successful candidates must satisfy the Civil Service Commissioners on their health and character.

7. *Competition.*

(i) The competition comprises:—

(A) A written examination in

(a) three compulsory subjects, Essay, English, and Present Day, each with a maximum of 100 marks, and

(b) a selection from the optional subjects set out in the Appendix. Subject to the provisions in the Appendix, candidates may take optional subjects up to a total of 500 marks. (The marks awarded on these optional subjects will be adjusted to a maximum of 700 marks, making 1,000 marks in all for the written examination).

(B) An interview before the Final Interview Board, which will award a mark out of a maximum of 300 for the candidate's record, intelligence, and personal qualities.

(ii) The final order of merit will be determined by candidates' total marks gained in the whole competition.

(iii) No candidate will be declared successful who does not reach a standard satisfactory to the Commissioners.

8. *Candidates Trained as Teachers.*

Candidates who have been trained as teachers, elsewhere than in England and Wales, and upon whose training public money has been spent, cannot be appointed until the consent of the appropriate education authority (e.g., the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

9. *Assignment.*

The Commissioners will decide to which Department each successful candidate is to be assigned. Assignments will be made in accordance with the needs of the public service, but the wishes of candidates will, where possible, be taken into account. A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment.

In order to be eligible for assignment to Branch B of the Foreign Service candidates will be required to satisfy the Final Interview Board that they have the ability to learn languages.

10. *Canvassing.*

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them on their application forms, will disqualify them for appointment.

11. *Fee.*

The total fee payable by all candidates is £2. Of this £1 must be paid on application.

12. The Commissioners' decision will be final in all matters concerning this competition.

The Civil Service Commissioners further give notice that an Open Competition will be held under the above Regulations, the written examination commencing on 1st July, 1958.

But (a) a candidate who has served or is serving in H.M. Forces may deduct from his actual age the period of such service rendered before the 1st August, 1958;

(b) a candidate who has post-graduate experience approved by the Commissioners may deduct from his actual age the period of such experience gained before the 1st August, 1958, up to a maximum of three years.

4. Nationality.

To be eligible for appointment a candidate must be a British subject, a British protected person or a citizen of the Irish Republic and in addition satisfy one of the following conditions:—

(a) if he was a British subject, a British protected person or a citizen of the Irish Republic at birth—

THE NATIONAL INSURANCE (DEATH GRANT) (CONSEQUENTIAL PROVISIONS) REGULATIONS, 1957.

IN accordance with Section 77 of the National Insurance Act, 1946, the National Insurance Advisory Committee give notice that they have received from the Joint Authority (comprising the Minister of Pensions and National Insurance and the Minister of Labour and National Insurance for Northern Ireland) for consideration and report thereon the preliminary draft of regulations entitled the National Insurance (Death Grant) (Consequential Provisions) Regulations, 1957.

A short explanatory note on these regulations is appended to this notice.

If an objection is submitted within the prescribed time, however, the Committee will be prepared, if they are satisfied that sufficient grounds exist, to allow the later submission of evidence or explanation in support of the objection. EXPLANATORY NOTE

These Regulations, which are made in consequence of the provisions concerning death grant in the National Insurance Act, 1957, apply certain provisions of the National Insurance (Claims and Payments) Regulations, 1948, to claims for, and payments of, death grant as if it were a benefit due to the deceased at his death. They amend the National Insurance (Death Grant) Regulations, 1949, with respect to deaths abroad and add new provisions to those regulations with respect to the persons on whose insurance death grant may be paid in the case of a child.

The remaining provisions are of a minor or consequential character.
