Vehicles would be prohibited from waiting on High Street, Kinross -

•

(1) on the west side from Station Road to School Wynd and on the east side from a point approximately 45 yards south of Station Road to School Wynd;

(2) on the east side from Station Road for a distance of 45 yards in a southerly direction for a period longer than 20 minutes in any hour;
