TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 14th August 1959, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £250.000.000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 17th August 1959, to Saturday the 22nd August 1959, inclusive and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker. Discount House or Broker.
- 6. Notification will be sent by post on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

WAGES COUNCILS ACT. 1945 to 1959

BOOT AND SHOE REPAIRING WAGES COUNCIL (GREAT BRITAIN)

THE Boot and Shoe Repairing Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Boot and Shoe Repairing) Order, 1956 (Order D.(117)) as amended by the First Schedule to the Wages Regulation (Boot and Shoe Repairing) (Amendment) Order, 1958 (Order D.(123)), (2) the same amendments to the Wages Regulation (Boot and Shoe Repairing) (Holidays) Order, 1956 (Order D.(119)) as are now contained in the Second Schedule to Order D.(123), and (3) the revocation of Order D.(123).

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within fourteen days from 11th August, 1959. The National Insurance (Non-participation—Benefits and Schemes) Regulations, 1959

IN accordance with Section 77 of the National Insurance Act, 1946, the National Insurance Advisory Committee give notice that they have received from the Minister of Pensions and National Insurance for consideration and report thereon the preliminary drafts of regulations respectively entitled the National Insurance (Non-participa-

tion—Certificates) Regulations, 1959, the National Insurance (Non-participation—Appeals and References) Regulations, 1959 and the National Insurance (Non-participation—Benefits and Schemes) Regulations, 1959.

Short explanatory notes on these regulations are appended to this notice.

EXPLANATORY NOTES.

National Insurance (Non-participation—Certificates) Regulations, 1959

These Regulations provide in Part I for the appointment of a Registrar and deputy Registrars for the purpose of the issue to employers of certificates specifying employments which are to be treated as non-participating employments and the variation, cancellation and surrender of such certificates and for the purpose of determining questions arising thereon as to whether any employment is to be treated as a non-participating employment. Part II prescribes the manner in which elections and revocations of elections are to be made by employers seeking the issue, cancellation or variation of a certificate. Part III provides for questions as to whether or for what period an employment is under any certificate, to be treated as non-participating in relation to any person, to be referred to the Registrar by the Minister and empowers the Registrar to appoint a person to hold an Inquiry before determining such a question.

Part IV prescribes the manner in which questions are to be determined by the Registrar and provides for appeals from his decisions to lie to the Adjudicator to whom the Registrar may also refer a question instead of determining it himself. This Part also provides for review by the Registrar of decisions on questions referred to him by the Minister under Part III.

The procedure for the issue, variation and cancellation of certificates by the Registrar is prescribed in Part V which also includes matters connected therewith.

National Insurance (Non-participation—Appeals and References) Regulations, 1959

These Regulations prescribe the procedure for determination by the Adjudicator appointed under Part II of the National Insurance Act, 1959 of any question whether an employment is to be treated as a non-participating employment or as to the persons in relation to whom or the period for which it is to be so treated. (The National Insurance (Non-participation—Certificates) Regulations, 1959, provide for the submission to the Adjudicator of any such question on appeal from a decision of or on reference by the Registrar). The Regulations include provision for oral hearings and other procedural matters and contain a power for the Adjudicator, on a reference or appeal to him, to review decisions given by himself or the Registrar on questions whether any employment is to be treated as a non-participating employment in relation to any person or the period for which it is to be so treated.

National Insurance (Non-participation—Benefits and Schemes) Regulations, 1959

These Regulations contain conditions for treating occupational pension benefits as equivalent to State graduated benefits and for the recognition of pension schemes or arrangements.
