The QUEEN'S Most Excellent Majesty in Council Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 11th day of August 1959 (N.P. 2471/59) in the words following viz.:—

"Whe eas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or allowances in the mature thereof, payable in respect of services in Your Majesty's Naval or Marine Forces to a person being or having been an Officer, Seaman of Marine therein, or to the widow or relation of a deceased Officer, Seaman or Marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

"And whereas by the Pensions (Increase) Acts, 1920, 1924, 1944, 1947, 1952 and 1956, provision is made subject to certain conditions and restrictions, for the increase of certain civil pensions payable in respect of public service:

<sup>\*</sup> And whereas by Orders in Council dated the 13th August, 1920, 8th December, 1924, 25th June, 1925, 1st February, 1926, 28th September, 1944, 24th January, 1945, 20th March, 1946, 2nd April, 1947, 4th September, 1952, 3rd June, 1954 and 9th Octoben, 1956, provision is made for the increase of certain Naval pensions and other awards including awards administered by the Ministry of Pensions and National Insurance, to correspond, as nearly as may be with the benefits provided by the aforementioned Pensions (Increase) Acts: in force before 4th November, 1958.

- (b) Service retired pay and the service portion of disability retired pay of members of Queen Alexandra's Royal Naval Nursing Service and Nursing Service Reserve if assessed under regulations in force before 4th November, 1958.
- (c) Men's service pensions, including elements for rank and age and additions for war service, if assessed under regulations in force before 4th November, 1958.
- (d) Pensions payable under Order in Council of 23rd May, 1952, and previous Orders relating to Riggers and Ya deraft personnel if beginning before the relevant date.
- (e) Pensions payable under Order in Council of 3rd July, 1939, and previous Orders relating to European and Indian members of the Hong Kong Dockyard Police it beginning before the relevant date.
- (f) Pensions payable under Order in Council of 3rd July, 1939, relating to European and Indian (or otherwise Asian) members of the Singapore Dockyard Police if beginning before the relevant date.
- (g) Pensions payable under Order in Council of 23rd May, 1952, and previous Orders relating to certain Shipwrights if beginning befo.e the relevant date.
- (h) Officers' and Men's widows 'ordinary' pensions and children's 'ordinary' pensions if assessed under regulations in force before 4th November, 1958.

"And whereas we now deem it expedient to make further provision for the increase of such awards to correspond, as nearly as may be, with the benefits provided, in the case of centain civil pensions, by the Pensions (Increase) Act, 1959.

<sup>34</sup>We beg leave humbly to recommend that Your Majesty may be graciously pleased by your Order in Council to sanction the provisions set out in the Schedules annexed hereto with effect from 1st August, 1959.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

#### "SCHEDULE I

b" This Schedule relates to :---

? (a) Officers' service retired pay and the service portion of disability retired pay if assessed under regulations

- (i) Pensions for distinguished conduct.
- (j) Meritonious Service Annuities payable to Royal Marines when the recipient is also receiving another pension increasable under this Schedule.
- (k) Retired Officers' Naval Pensions and Good Service Pensions.
- (1) Any award increased under Orders in Council of 13th August, 1920, or 8th December, 1924, or which would have been increasable under those Orders but for the income limits imposed thereby.
- (m) Pensions payable under Orders in Council of 11th July, 1951, and previous Orders relating to Officers of the Royal Fleet Auxiliary Service if beginning before the relevant date.
- (n) Pensions payable under Order in Council of 30th August, 1954, relating to certain ratings of the Royal Fleet Auxiliary Service if beginning before the relevant date.
- (o) Service retired pay of Officers of the former Royal Indian Navy.

Note. Additions to pension in respect of gallantry awards shall for the purposes of this Schedule beregarded as forming a part of the pension to which they are attached. "2. An award to which this Schedule relates may be increased provided that:—

- (a) the pensioner has attained the age of 60 years or, where the pension is a widow's pension, 40 years or,
- (b) the pensioner, if receiving a pension as the child of a deceased Officer. Rating or Other Rank, has not attained the age of 16 years, or, having attained that age, is receiving full time instruction in an educational establishment, or is undergoing training for a trade, profession or vocation in such circumstances that he is required to devote the whole of his time to that training for a period of not less than two years; or
- (c) the pensioner was invalided from the Naval service; or
- (d) the pensioner is a woman with at least one dependant as defined in Clause 6; or
- (e) the pensioner is permanently incapacitated by reason of mental or physical infirmity from engaging in any regular form of full time employment.

"3. The amount of the increase shall be the appropriate percentage, as set out in Clause 4, of the pension currently in payment to the pensioner, including any pensions increase awarded or admissible under former Pensions Increase Orders in Council. For the purpose of the calculation only, a fraction of a pound in an annual rate of pension will be treated as a whole pound, and a fraction of sixpence in a weekly rate of pension will be treated as a whole sixpence. The pension increase, however, will be added to the actual pension in payment.

Any part of the pension which has been commuted before the 1st August, 1959, shall be disregarded in assessing the increase permissible and where commutation is effected on or after 1st August, 1959, the amount so commuted may nevertheless be included as if it were still part of the pension in assessing the increase permissible. the minimum increase will be the amount of increase which could be given on the rate of retired pay awarded for service on the active list.

"2. In the case of the pensions specified at (d) (e) (f) (g) (m) and (n) of Schedule I, the award may be increased only to the extent to which a corresponding award under the Superannuation Acts would have been increasable under the Pensions (Increase) Act, 1959.

#### "SCHEDULE III

" General Provisions

"Any genreal conditions attaching to the grant or continuance of a pension shall also apply to the grant or continuance of any increase to that pension.

The expression 'pension' in the Schedules to this Order in Council includes any award increaseable under its provisions, or under the provisions of former Pensions Increase Orders in Council.

The expression 'the relevant date' in Schedule 1 means 2nd April, 1957.

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"4. The appropriate percentage increase shall be as follows:—

- (a) For pensions (other than family pensions) assessed in accordance with regulations which were in force before 1st April, 1956, 12 per cent.
- (b) For pensions (other than family pensions) assessed in accordance with regulations introduced after 31st March, 1956, but excluding any awards made under regulations introduced on or after 4th November, 1958, 4 per cent.
- (c) For family pensions assessed in accordance with regulations which were in force before 4th November, 1958, 10 per cent.

"5. Where the service retired pay award to an officer retiring after 3rd November, 1958, is assessed under regulations in force prior to 4th November, 1958, but with an addition to that retired pay provided under regulations introduced on or after 4th November, 1958, pensions increase under this Order in Council shall not be admissible. The officer, however, may be granted instead of his service retired pay award with, in lieu of the said addition, the appropriate pensions increase thereon.

"6. The expression 'dependant' for the purpose of Clause 2 (d) shall mean a person wholly or mainly supported by the pensioner and who either

(a) has not attained the age of 16 years or, who having attained that age, is receiving full time instruction at an educational establishment or undergoing training for a trade, profession or vocation in such circumstances that he is required to devote the whole of his time

- (a) the retired pay earned by service on the active list shall be increased by the amount of pensions increases appropriate at the date of the officer's final retirement: the additional retired pay earned by service in the salaried appointment after being placed on the retired list shall then be added to the original retired pay, increased as above, and the whole amount treated as a civil pension dating from final retirement; but
