

EAST LOTHIAN WATER BOARD WATER ACT 1958

NOTICE is Hereby Given that in consequence of an exceptional shortage of rain whereby a serious deficiency of supplies of water is threatened within the limits of supply of the East Lothian Water Board, the Board have applied to the Secretary of State for an Order under Section 1 of the Water Act 1958 and all other powers vested in the Secretary of State in that behalf authorising them to reduce the quantities of compensation water and to take water from additional sources, as follows:—

(a) Reduction of Compensation Water.

From 300,000 gallons to 200,000 per day.

Stobshiel Reservoir-

From 123,000 gallons to 23,000 per day.

Lammerloch Reservoir-

From 110,000 gailons to 10,000 per day.

Donolly Reservoir-

From 140,000 gallons to 40,000 per day.

Thorters Reservoir-

From 147,000 gallons to 47,000 per day.

(b) Taking of Water from additional sources.

(1) To provide that the rate of flow in the White-adder River below which the Board are not entitled to abstract water in pursuance of Section 26 of the said East Lothian Water Board Water Order shall be fixed at 1,300,000 gallons per day.

(2) To abstract water from the Humbie Water at a point near Duncrahill by pumping subject to a maximum daily quantity of 500,000 gallons per day.

Copies of a map showing the proposals may be inspected by any person free of charge at the County Buildings, Haddington, during normal office hours, during the period 16th to 24th October, 1959, inclusive.
