 - (ii) the sum of two shillings and sixpence where the distance between the group centres (as defined in 1(a)(i) above) appropriate on the one hand to the coast radio station and on the other hand to the Subscriber's line to which the call is made. exceeds 35 miles, with, if the duration of the call exceeds 3 minutes, a further sum of tenpence for each minute or part of a minute in excess of the first 3 minutes;
- (b) the coast station charge—the sum of four shillings together with if the duration of the call exceeds 3 minutes, a further one shilling and fourpence for each minute or part of a minute in excess of the first 3 minutes; and
- (c) the ship charge—the sum of two shillings and sixpence together with, if the duration of the call exceeds 3 minutes, a further tenpence for each minute or part of a minute in excess of the first 3 minutes.
