The QUEEN has been graciously pleased to ordain and declare that Winifred Anne Grizel Cochrane shall henceforth have, hold and enjoy the title, rank, place, pre-eminence and precedence as the daughter of an Earl which would have been due to her had her father, Douglas Robert Hesketh Roger Cochrane (commonly called the Honourable Douglas Robert Hesketh Roger Cochrane), survived his brother, Thomas Hesketh Douglas Blair, Earl of Dundonald, in the Peerage of Scotland, sometime a Representative Peer for Scotland, and thereby succeeded to the said title and dignity of Earl of Dundonald.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms and in Her Majesty's Lyon Office in Edinburgh.

The QUEEN has been pleased, by Warrant signed by Counsellors of State and bearing date the 6th instant, to direct the issue of a Commission under the Seal appointed by the Treaty of Union to be kept and made use of in place of the Great Seal of Scotland granting the Office of Her Majesty's Advocate for Scotland to the Right Honourable William Grant, Q.C., M.P.

At Dover House, Whitehall, London, on Wednesday the sixth day of April Nineteen hundred and sixty, The Right Honourable William Grant, Q.C., M.P., took the Oath of Allegiance and the Official Oath on his appointment as Lord Advocate in the presence of The Right Honourable John Scott MacLay, C.M.G., M.P., Secretary of State for Scotland in the forms set out in the Schedule hereto.

## TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949

THE Secretary of State gives notice that he has made a Variation Order under sections 1 and 13 of the Trunk Roads Act, 1936, as extended by section 14 of the Special Roads Act, 1949, and as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which is that the London-Carlisle-Glasgow-Inverness Trunk Road (Blackwood and Canderwater Diversions) Order, 1938, will be varied in that a new part route will be substituted for part of the route of the new trunk road which he proposes to construct near Blackwood in the County of Lanark.

Any Person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1946, as extended by the said Act of 1949 or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of the twelfth day of April, 1960, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

## TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949

THE Secretary of State gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, to provide for (a) the construction by the Secretary of State of a new road in substitution for a length of Ecclaw Road near Chapelhill in the County of Berwick authorised to be stopped up by the Order, (b) the stopping up of a length of the said Ecclaw Road and two lengths of the London-Edinburgh-Thurso Trunk Road when the new road and new trunk road which the Secretary of

State proposes to construct near the said Chapelhill are opened for the purposes of through traffic and (c) the Berwick County Council becoming the highway authority for the new road on the date on which notice is given by the Secretary of State to the Council that the new road is opened for the purposes of through traffic.

### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Thursday, 14th April 1960, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £280,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Tuesday the 19th April 1960, to Saturday, the 23rd April 1960, inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

#### Explanatory Note

These Regulations make provision for the payment of graduated contributions and of payments in lieu of contributions.

Graduated contributions (except those payable in respect of seamen) are brought within the Pay As You Earn scheme for purposes of payment, accounting and recovery, although the Minister may authorise other arrangements for payment. Employers may be required to give information needed to ascertain whether there is any liability for graduated contributions in respect of employees for whom such contributions have not been paid.

If at the end of an employee's service in a non-participating employment a payment in lieu of contributions becomes due it is to be made to the Minister.

#### THE MINES AND QUARRIES ACT, 1954 THE COAL MINES (TRAINING) (VARIATION) REGULATIONS, 1960

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he proposes to make General Regulations under Sections 141 and 143 of the Act, entitled the Coal Mines (Training) (Variation) Regulations, 1960.

These regulations, which will apply to mines of coal, vary the provisions of the Coal Mines (Training) Regulations, 1956.

Regulation 2 of the Coal Mines (Training) Regulations, 1956, prohibits the employment in a coal mine of any person who has not previously been employed in any mine unless, as nearly as may be immediately before he is first employed in the coal mine, he has received certain training described in reg. 3 of those regulations. Re. 8(2) of those regulations exempts apprentice mechanics and apprentice electricians from the requirements of reg. 2 if they have received the training described in reg. 3 at any time previously or training in accordance with reg. 8(2)(b) which is for a shorter period than that described in reg. 3(1).

These regulations extend the exemption contained in reg. 8(2) to any apprentice who is employed in accordance with the provisions of an apprenticeship scheme approved by the Minister of Power.
