Now, therefore, Her Majesty, in exercise of the powers con rred upon Her as aforesaid and of all other powers what oever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows: £52 a year to £104 a year, the maximum amount which a pensioner may earn and nevertheless be deemed to be unemployable for the purpose of an award of the allowances for unemployable pensioners.

This Order amends the Order of the 29th September 1949, as amended by subsequent Orders, and increases, from the Order concerning retired pay, pensions and other grants in cases where the disablement or death of members of the naval forces is due to service after the 2nd September 1939:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated the 29th September 1949, relating to members of the naval forces as therein defined, as amended by the Orders in Council of the 28th October 1949, of the 31st May 1951, of the 29th April 1952, of the 18th July 1952, of the 28th May 1953, of the 5th January 1955, of the 29th June 1956, of the 24th January 1957, of the 27th November 1957, and of the 13th May 1959, shall be further amended in the respects set out in the following Articles of this Order which shall be construed as one with the said Order of the 29th September 1949.

1. In proviso (a) to paragraph (1) of Article 17 (which provides for the supplementation of retired pay or pension and the award of allowances for unemployable pensioners) for the figures  $\pounds 52$  there shall be substituted the figures  $\pounds 104$ .

2. This Order shall come into operation on the 1st May 1960.
