MAINS OF CHARLESTOWN AND OTHER  
DIVERSIONS

THE Secretary of State gives notice that he proposes to make an Order under section 1 of the Trunk Roads Act, 1946, as extended by section 14 of the Special Roads Act, 1949, and as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be that three diversions which he proposes to construct near Mains of Charlestown in the County of Kincardine will become trunk roads on the date when the Order comes into operation, and those lengths of the Perth-Aberdeen-Inverness Trunk Road to be superseded thereby will cease to be trunk roads on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the Kincardine County Council (who will thereafter become the highway authority responsible for those lengths) that the said diversions are opened for through traffic.
