TENDERS FOR TREASURY BILLS

THE MINES & QUARRIES ACT, 1954 THE COAL MINES (FIREDAMP DRAINAGE) REGULATIONS, 1960

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he proposes to make General Regulations under Section 141 of the Act, entitled the Coal Mines (Firedamp Drainage) Regulations, 1960.

The Regulations, which will apply to mines of coal and. will come into force on the 1st July 1960, govern the collection of firedamp before it has been diluted by the ventilation of the mine and its safe disposal. They do not apply to systems which consist merely of a pipe placed in a roadside

pack for the purpose of collecting firedamp which has accumulated behind the pack and conveying it to a point in the road where it can be discharged safely.

The Regulations make provisions governing the drilling of boreholes, the installation and construction of stand pipes, pipe ranges and exhausters, the construction and use of exhauster houses and calorimeter rooms and the conditions under which firedamp is discharged from a firedamp drainage system.
