DANGEROUS DRUGS ACT, 1951 WITHDRAWAL OF AUTHORITIES

(Peter Louis Milbourne Hartley)

WHEREAS PETER LOUIS MILBOURNE HARTLEY, M.B., B.Ch., M.R.C.S., L.R.C.P., whose registered address is 408 Wimbledon Park Road, London S.W.19, has been convicted of offences against the Dangerous Drugs Act, 1951:

And I hereby direct that it shall not be lawful for the said Peter Louis Milbourne Hartley to give prescriptions for the purpose of the Dangerous Drugs Regulations, 1953.

TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949

THE Secretary of State gives notice that he has made an Order under section 1 of the Trunk Roads Act, 1946, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which is that seven diversions which he proposes to construct between Helmsdale and Dunbeath in the Counties of Sutherland and Caithness will become trunk roads on the date when the Order comes into operation and the lengths of trunk road to be superseded thereby will cease to be a trunk road on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the County Councils of Sutherland and Caithness (who will thereafter become the highway authorities responsible for the said lengths in their respective counties) that the said diversions are opened for through traffic.
