TRUNK ROADS ACT, 1946
SPECIAL ROADS ACT, 1949

THE Secretary of State gives notice that he has made "The London-Carlisle-Glasgow-Inverness Trunk Road (Lockerbie Diversion Improvements) Order, 1960" under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, which trunk road Order provides for (a) the improvement by re-grading of lengths of the Limestonerigg-Lockerbie Road, the Annan-Lockerbie Road, the Dumfries-Lockerbie Road, Annandale Avenue, the Muirhead-Turnmuir Road and the Beckton-Dam Road, all in or near the Burgh of Lockerbie in the County of Dumfries, (b) the construction by the Secretary of State of seven new roads in substitution for those lengths and parts of the Limestonerigg-Lockerbie Road, the Annan-Lockerbie Road, Quaas Loaning, the Muirhead-Turnmuir Road, the Beckton-Dam Road and the London-Carlisle-Glasgow-Inverness Trunk Road authorised to be stopped up by the Order, (c) the stopping up of lengths and parts of the Limestonerigg-Lockerbie Road, the Annan-Lockerbie

Road, Quaas Loaning, the Muirhead-Turnmuir Road, the Beckton-Dam Road and the London-Carlisle-Glasgow-Inverness Trunk Road when the said new roads are opened for the purposes of through traffic, and (d) the Dumfries County Council and Lockerbie Town Council becoming the highway authority for the new roads as appropriate on the date on which notice is given by the Secretary of State to the said Councils that the new roads are opened for through traffic.

Copies of the Order and of the relative plan have been deposited at the Scottish Home Department, Bankhead Avenue, Sighthill, Edinburgh 11, from whom copies of the Order can be obtained, and at the offices of the Dumfries County Council, County Buildings, Dumfries, and may be seen at all reasonable hours.

Any Person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1949 or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of the seventeenth day of May 1960 apply to the Court of Session for the suspension of quashing of the Order or of any provision contained therein.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, 20th May 1960, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £260,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 23rd May 1960, to Saturday, the 28th May 1960, inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
