3. The Bills will be issued and paid at the Bank of England.

(being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

THE COAL MINES (COMPRESSED AIR BLASTING SHELLS) REGULATIONS, 1960

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I. of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he proposes to make General Regulations under Sections 69 and 141 of the Act, entitled the Coal Mines (Compressed Air Blasting Shells) Regulations, 1960.

The Regulations, which will apply to mines of coal and will come into force on 1st August 1960, govern the use of blasting devices which depend for their action on the discharge of high pressure compressed air. They are similar in content to the Coal Mines (Cardox and Hydrox) Regulations, 1956.

One-Way Traffic:

Only One-Way Traffic will be permitted in the following lengths of streets, in the directions stated:

Colquhoun Street between its junction with Princes Street West and its junction with Clyde Street West. North to South.

James Street between its junction with Clyde Street West and its junction with Princes Street West. South to North.

John Street between its junction with Princes Street West and its junction with Clyde Street West. North to South.

Waiting Restrictions:

Waiting will be prohibited on the following lengths of streets at all times:

Colquhoun Street on the west side from its junction with Colquhoun Square to its junction with King Street West.

James Street on the east side from its junction with Princes Street West to King Street West.

Charlotte Street on the east side from its junction with Clyde Street East to its junction with Princes Street East.

Maitland Street on the west side for its whole extent.

Princes Street East on the north side from its junction with Charlotte Street to a point opposite its junction with Maitland Street.

King Street West on the north side from its junction with Sinclair Street to its junction with John Street.

King Street East on the north side from its junction with Sinclair Street to its junction with Grant Street.

King Street East on the south side from its junction with Grant Street to its junction with Charlotte Street.

Clyde Street East on the south side from its junction with Hanover Street to its junction with Sinclair Street.

Clyde Street West on the south side from its junction with Sinclair Street for its whole extent westward to the Burgh Boundary.

Waiting will be prohibited in the following lengths of streets between the hours of 8 a.m. and 6 p.m.:

Sinclair Street on the east side from its junction with Princes Street East to its junction with King Street East.

John Street on the east and west sides for a distance of approximately 60 yards northwards from its junction with Clyde Street West to West End Garage.

Princes Street East on the north side from Sinclair Street to a point opposite its junction with Maitland Street.

Only unilateral waiting will be permitted in the following lengths of streets on alternate days, limited to 30 minutes in any period of one hour: Between the hours of 8 a.m. and 6 p.m.:

Sinclair Street from its junction with Clyde Streets East and West to its junction with Princes Streets East and West.

Colquhoun Street from its junction with Clyde Street West to its junction with Colquhoun Square.

Princes Street West from its junction with Sinclair Street to its junction with James Street but excluding Colquhoun Square.

Between the hours of 8 a.m. and 11 p.m.:

James Street from its junction with Clyde Street West to its junction with Princes Street West.

Waiting will be prohibited in the following lengths of streets for a period of more than 30 minutes in any period of one hour between the hours of 8 a.m. and 6 p.m.:

Sinclair Street west side from its junction with Princes Street West to its junction with King Street West.

Clyde Street East on the north side from its junction with Maitland Street to its junction with Sinclair Street.

Clyde Street West on the north side from its junction with Sinclair Street to its junction with William Street.

Princes Street East on the south side from its junction with Maitland Street to its junction with Sinclair Street.

Waiting will be prohibited at all times where street markings indicate that space should be left clear for buses halting at recognised bus halts.

The above waiting restrictions will apply, except upon the direction, or with the permission, of a police constable in uniform and only between the hours indicated.

SCHEDULE.

The Order prohibits the driving of any heavy locomotive, light locomotive, motor tractor, or heavy motor car, or any motor car with seats for more than 15 persons, exclusive of the driver, on that length of the Loch of Boath-Drynachan-Dulsie Road (Unclassified) which extends from its junction with the Cawdor-Clunas-Aitnoch Road (Class III) at Balmore of Boath, via Drynachan Lodge, Carnoch and Banchoir to its junction with the Cawdor-Clunas-Aitnoch Road near Dulsie, including the branch road from Drynachan Lodge past Daless to the Ford at Quilochan.

Exceptions have been provided in the Order in respect of any vehicle being used in the conveyance of persons, goods or merchandise to or from any premises on or adjacent to the length of road; for agricultural purposes; or in connection with building or demolition operations, the removal of any obstruction to traffic or the maintenance of the road or the services therein.
