STIRLINGSHIRE**

The Import Duty Drawbacks (No. 7) Order, 1960.

This Order makes the amendments to existing Import Duty Drawbacks Orders which are required in consequence of the reduced rates of duty applicable from 1st July 1960 under the European Free Trade Association Convention. It preserves the present eligibility for drawback of certain goods, exported either without change of state or incorporated in other goods, whose eligibility is related to the rate of duty; provides, where necessary, for revised rates of drawback on exported goods produced or manufactured from imported articles certain of which will bear reduced rates of duty; and, to avoid inappropriate reductions in rates of drawback on goods produced or manufactured from imported articles where the rates of drawback are already calculated by reference to varying levels of duty paid, provides in certain cases that paragraph 3(2) (a) of the Fifth Schedule to the Import Duties Act, 1958 (which relates to proportionate reductions in drawback rates for imported articles charged with preferential rates of duty) shall not apply.

The Import Duties (European Free Trade Association) Order, 1960

This Order reduces the import duty chargeable under the Import Duties Act, 1958, on certain goods grown, produced or manufactured in, and consigned from a place in, the Convention area.

The Convention area is defined in section 10(1) of the European Free Trade Association Act, 1960, and at present covers Austria, Denmark, the United Kingdom, the Isle of Man and the Channel Islands, Liechtenstein, Norway (including Spitzbergen), Portugal (including the Azores and Madeira), Sweden and Switzerland.

The reduction is one-fifth of the existing rates of import duty except in the case of (a) the goods specified in the First Schedule to the Order (but not in the Second Schedule), no reduction in the rates of duty being made for these, and (b) the goods specified in the Second Schedule, which are to be charged at the particular Convention rates shown in that Schedule or, in the case of canned cream, blue veined cheese and certain steel rods, are to be free of import duty.

THE COAL AND OTHER MINES (VENTILATION)  
(VARIATION) REGULATIONS, 1960

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he proposes to make General Regulations under Sections 141 and 143 of the Act, entitled the Coal and Other Mines (Ventilation) (Variation) Regulations, 1960.

These Regulations will apply to mines of coal, stratified ironstone, shale and fireclay, and will vary the Coal and Other Mines (Ventilation) Regulations, 1956.

Regulation 7(5) of the Coal and Other Mines (Ventilation) Regulations, 1956, provides that determinations of firedamp content required to be made in mines of coal, stratified ironstone, shale or fireclay, once in every week or thirty days must be made at the appropriate stage of the mining operations on the last working day of the week, other than a Saturday, on which the operations comprise that stage.

These regulations implement a recommendation of the Report on the explosion at Walton Colliery (1) by varying the 1956 Regulations so that such determinations may be made at any time during the shift commencing on a Friday and ending on a Saturday if the appropriate stage of the operations occurs at that time.

SALMON FISHERIES (SCOTLAND) ACTS, 1828 to 1868  
THE DISTRICT OF SHETLAND (ANNUAL CLOSE  
TIME) ORDER, 1960

THE Secretary of State, in exercise of the powers conferred on him by section 9 of the Salmon Fisheries (Scotland) Act, 1868 (a), and of all other powers enabling him in that behalf, on the petition of the Shetland Salmon Fishery District Board, hereby orders as follows:

1. (1) This Order may be cited as the District of Shetland (Annual Close Time) Order, 1960, and shall come into operation on the 9th day of September, 1960.
- (2) The Interpretation Act, 1889(b), shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. The annual close time for the District of Shetland shall extend from the 10th day of September in each year until the 24th day of February in the year next ensuing, both days inclusive.
3. Notwithstanding anything in the last preceding paragraph, it shall be lawful to fish for, and to take, salmon with the rod and line in the said District during the following period in any annual close time, that is to say from the commencement of the close time until the 31st day of October inclusive.

4. The Byelaw relating to the annual close time for the District of the River Sandwater, etc., (Shetland Islands) made by the Fishery Board for Scotland on 8th February 1883 and confirmed by the Secretary of State on 5th May 1883, is hereby revoked.
