

The QUEEN'S Most Excellent Majesty in Council.

Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 29th day of June 1960 (N.P. 2400/60) in the words following, viz.:

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by Orders in Council dated 29th March 1949, and 2nd November 1950, a system of National Service grants was instituted:

"And whereas by Order in Council dated 1st November 1956, it was provided that the maximum of the Grants should be £5:

"And whereas we are of the opinion that the maximum

Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949

ECCLAW ROAD IMPROVEMENTS, BERWICKSHIRE

THE Secretary of State gives notice that he has made "The London-Edinburgh-Thurso Trunk Road (Ecclaw Road and Other Improvements) Order, 1960," under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, which trunk road Order provides for (a) the construction by the Secretary of State of a new road in substitution for a length of Ecclaw Road near Chapelhill in the County of Berwick authorised to be stopped up by the Order, (b) the stopping up of a length of the said Ecclaw Road and two lengths of the

London-Edinburgh-Thurso Trunk Road when the new road and new trunk road which the Secretary of State proposes to construct near the said Chapelhill are opened for the purposes of through traffic and (c) the Berwick County Council becoming the highway authority for the new road on the date when the Secretary of State notifies the Council that the new road is opened for through traffic.

Copies of the Order and of the relative plan have been deposited at the Scottish Home Department, Bankhead Avenue, Sighthill, Edinburgh 11, from whom copies of the Order can be obtained, and at the offices of the Berwick County Council, County Buildings, Duns, and may be seen at all reasonable hours.

Any Person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1949 or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of the sixteenth day of August 1960, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

The authorised fuels are: anthracite and semi-anthracite, bricquetted fuels, carbonised in the process of manufacture (i.e., prepared smokeless fuels), coke, electricity, gas, low temperature carbonisation fuels, and low volatile steam coals.
