THE EAST KILBRIDE WESTWOOD SMOKE
CONTROL AREA ORDER, 1960

- 1. NOTICE Is Hereby Given that the County Council of the County of Lanark in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the Sixth day of July 1960, made an Order entitled The East Kilbride Westwood Smoke Control Area Order, 1960, declaring the area described in the schedule hereto to be a Smoke Control Area which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding ten pounds unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.
- 3. Copies of the Order and of the map referred to therein may be inspected free of charge at the office of the County Clerk at Lanarkshire House, 191 Ingram Street, Glasgow, and at the Office of the County Sanitary Inspector, Beckford Street, Hamilton, and at the Offices of the Department of Health for Scotland, St. Andrew's House, Edinburgh 1, at all reasonable times during the period of six weeks from the twenty-seventh day of August in the year 1960. Within the said period any person who will be affected by the Order may, by writing to the Secretary of State for Scotland, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.

#### SCHEDULE

The area referred to in Paragraph 1 of this Notice is the area in the County of Lanark and also in the New Town of East Kilbride extending to four hundred and eighty acres or thereby comprising the whole of the area known as the Westwood Neighbourhood of the said New Town—all as the said area is contained within boundaries edged red and marked "Westwood" on the map referred to in the said Order.
