The QUEEN has been pleased by Letters Patent under the Great Seal of the Realm, bearing date the 17th instant, to confer the dignity of a Baronet of the United Kingdom upon Sir Kenneth Dugald Stewart, of Strathgarry in the County of Perth, G.B.E., and the heirs male of his body lawfully begotten.

PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 25th day of July 1960 (N.P. 2632/60) in the words following, viz.:

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Forces to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such a manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by Orders in Council dated 21st March 1924, 24th February 1948, 29th September 1949, 30th June 1955, 16th May 1956, and 19th December 1956, sanction was given, *inter alia*, to certain scales of gratuities for long service, or on invaliding for non-attributable causes, to Locally Entered Petty Officers and Men of Your Majesty's Naval Forces:

"And whereas we are of the opinion that in so far as they affect Goan, Somali, West African, St. Helenian and Bantu Petty Officers and Men of Your Majesty's Naval Forces, revised scales and conditions for the award of gratuities should be introduced:

"We beg humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction, with effect from 1st September 1959, the revised arrangements set out in the annexed Schedule:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal:

" SCHEDULE

The provisions of this Schedule apply to all Goan, Somali, West African, St. Helenian and Bantu Locally Entered ratings who are discharged from the Naval Service after the 31st August 1959, (cease pay date).

" SECTION I

"2. A rating discharged otherwise than for misconduct, or for inefficiency due to causes within his own control, and who has completed at least 22 years' reckonable service may be awarded a gratuity consisting of the sum of elements for service and rank assessed as follows:

"3. A rating who while serving on a non-continuous service engagement is invalided and who has completed at least 12 years' reckonable service may be awarded a gratuity consisting of the sum of elements for service and rank assessed as follows:

"4. In assessing rank element of gratuity, all paid rank will be taken into account.

"SECTION II

"5. A rating discharged without entitlement to a gratuity under Section I otherwise than for misconduct or for inefficiency within his own control and who has 12 or more years' reckonable service preceding discharge may be awarded a service gratuity assessed as follows:

"6. A rating who is invalided with insufficient service to qualify for a gratuity under Section I and who has 5 or more years' reckonable service may be awarded a service gratuity assessed as follows:

For service of 12 years or more the invaliding scale given in Clause 3 will apply.

"7. Reckonable service for the purpose both of determining entitlement to gratuity and of assessing the rate of gratuity under Section I and II will be as for Naval ratings generally. In calculating reckonable service, all satisfactory periods of full pay service may be aggregated, except that service preceding a five year interval in service will not be reckonable service unless specially so allowed by the Admiralty. No period in respect of which a gratuity has already been paid may be allowed to reckon unless such gratuity is repaid either as a lump sum or by deductions from pay.

"8. Where a rating is discharged for misconduct, or for inefficiency within his own control, the amount of the gratuity shall be at Admiralty discretion, but where the discharge is for misconduct the amount shall not in any event exceed 90 per cent. of the award which would have been admissible had the rating been discharged on other grounds.

"9. A service gratuity will not be admissible on re-engagement or on discharge for the purpose of giving further full pay service in the Armed Forces.

"10. If a rating dies while serving no gratuity will be payable."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 26th August 1960, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £290,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 29th August 1960, to Saturday, the 3rd September 1960, inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the

amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

THE MINES AND QUARRIES ACT, 1954 THE COAL MINES (PRECAUTIONS AGAINST INFLAMMABLE DUST) (VARIATION) REGULATIONS, 1960

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he proposes to make General Regulations under Sections 141 and 143 of the Mines and Quarries Act, 1954 entitled the Coal Mines (Precautions against Inflammable Dust) (Variation) Regulations, 1960.

The Regulations, which apply to mines of coal and amend the Coal Mines (Precautions against Inflammable Dust) Regulations, 1956, require the provision of stone dust barriers, of a type approved by the Minister and in accordance with a scheme made by the Manager of the mine, in certain coal conveyor roads.

The Regulations will come into force on 1st October 1960, but will not apply to small mines licensed under Section 36(2)(a) of the Coal Industry Nationalisation Act, 1946, until 1st April 1961.
