IRON AND STEEL ACT, 1953

Price Determination by the Iron and Steel Board

NOTICE Is Hereby Given that the Iron and Steel Board have, pursuant to section 8 of the Iron and Steel Act, 1953, by an instrument in writing which will be known as Iron and Steel Board Price Determination 1961, No. 1, varied the Iron and Steel Board Price Determination 1960, No. 3.

PUBLIC INQUIRY FACTORIES ACTS, 1937 to 1959

ON 28th October 1960, the Minister of Labour published draft regulations entitled The Construction (General Provisions) Regulations, and The Construction (Lifting Operations) Regulations and gave notice, in accordance with Sec. 129 of the Factories Act, 1937, and the Second Schedule to that Act, of his intention to make Special Regulations as in that draft.
