#### TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949 CANDERWATER-LESMAHAGOW ROAD IMPROVEMENTS

THE Secretary of State gives notice that he proposes to make the following Orders:

1. An Order under section 1 of the Trunk Roads Act, 1946, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be that a slip road which he proposes to construct near Blackwood in the County of Lanark, connecting Strathaven Road with the proposed Blackwood Diversion, will become a trunk road on the date on which the Order comes into operation.

2. An Order under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, to provide for (a) the improvement by realigning and/or regrading of lengths of Draffan Road, Stonehouse Road, Strathaven Road, Vere Road, Milton and Carlisle Road all between Canderwater and Lesmahagow in the said County, (b) the construction by the Secretary of State of four new roads in substitution for lengths of the London-Carlisle-Glasgow-Inverness Trunk Road, Draffan Road, Stonehouse Road and part of Nethan Vale Terrace to be stopped up by the Order, and to provide improved junctions with the new trunk road which he proposes to construct between Canderwater and Lesmahagow, (c) the stopping up of lengths of the London-Carlisle-Glasgow-Inverness Trunk Road, Draffan Road, Stonehouse Road and part of Nethan Vale Terrace when the new roads and the new trunk road are opened for the purposes of through traffic, (d) the Lanark County Council becoming the highway authority for the new roads on the date on which notice is given by the Secretary of State to the Council that the new roads are opened for the purposes of through traffic.
