

### BILLS RECEIVING ROYAL ASSENT HOUSE OF LORDS

Westminster, London S.W.1.

9th May 1961.

THIS day the Lords being met, a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquainting them that The Lords authorised by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to the Acts agreed upon by both Houses, to desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read, and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:

White Fish and Herring Industries Act, 1961.

National Health Service Act, 1961.

Mersey Tunnel Act, 1961.

Allhallows Staining Churchyard Act, 1961.

Rio Tinto Rhodesian Mining Limited Act, 1961. Shell Brazil Act, 1961. Winchester Cathedral Close Act, 1961. Clerical, Medical and General Life Assurance Act, 1961. Great Northern London Cemetery Company Act, 1961. Lancashire Quarter Sessions Act, 1961.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturdav, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

### FACTORIES ACTS, 1937-1959
