THE EDINBURGH (SIGHTHILL No. 4) SMOKE CONTROL AREA ORDER 1961

The authorised fuels are: anthracite and semi-anthracite, bricquetted fuels, carbonised in the process of manufacture (i.e., prepared smokeless fuels), coke, electricity, gas, low temperature carbonisation fuels, and low volatile steam coals.
