TRUNK ROADS ACT, 1946
SPECIAL ROADS ACT, 1949
IMPROVEMENT AT JUNCTION OF A.8,
HILLINGTON ROAD AND MOSSLAND ROAD,
RENFREWSHIRE

THE Secretary of State gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, to provide for (a) the improvement by realignment and regrading of lengths of Hillington Road and Mossland Road in the Burgh of Renfrew, (b) the construction by the Secretary of State of a new road to provide an improved junction of Hillington Road and Mossland Road with the Glasgow-Greenock-Monkton Trunk Road (A.8) and Renfrew Road (A.8), (c) the stopping up of lengths of Hillington Road and Mossland Road when the said improved ro ds and the new road are opened for the purposes of through traffic, (d) the Renfrew County Council becoming the highway authority for the new road on the date on which notice is given by the Secretary of State to the Council that the new road is opened for through traffic and (e) the Glasgow Corporation becoming the highway authority for that part of the realigned and regraded length of Hillington Road lying within the City Boundary on the date on which notice is given by the Secretary of State to the Corporation that the improved length of road is opened for through traffic.

#### FACTORIES ACTS, 1937 to 1959

ON 5th June 1961, the Minister of Labour made The Flax and Hemp (Record of Humidity) Order 1961.
