TRUNK ROADS ACT, 1946
DIVERSION BETWEEN STRATHTYRUM LODGE
AND PETHERAM BRIDGE, ST. ANDREWS

THE Secretary of State gives notice that he proposes to make an Order under section 1 of the Trunk Roads Act, 1946, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be that a diversion which he proposes to construct between Strathtyrum Lodge and Petheram Bridge, St. Andrews, in the County of Fife, will become a trunk road on the date when the Order comes into operation and the length of the trunk road to be superseded thereby will cease to be a trunk road on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the Fife County Council and the St. Andrews Town Council, (who will thereafter become the highway authorities responsible for the part of the said length in their respective areas) that the said diversion is opened for through traffic.

BURGH OF PAISLEY CLEAN AIR ACT, 1956 THE PAISLEY No. 1 (FOXBAR) SMOKE CONTROL AREA ORDER, 1961

- 1. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuel, and low volatile steam coals.
- 3. The Order will not come into operation until at least six months after it is confirmed by the Secretary of State, and in any event not before 1st September 1962.
