The Order would prohibit vehicles from travelling otherwise than from south-east to north-west in High Street, Galashiels, from its junction with Bank Street/Overhaugh Street to its junction with Channel Street and in Bank Street from its junction with Market Street to its junction with High Street/Overhaugh Street. TENDERS FOR TREASURY BILLS

7. Members of the House of Commons are not precluded from tendering for these Bills.
