

DEPARTMENT OF HEALTH FOR SCOTLAND

PUBLIC HEALTH (IMPORTED FOOD (SCOTLAND) REGULATIONS 1937 to 1948

THE Secretary of State gives notice in pursuance of the above-named regulations, that he hereby recognises the official certificate of which particulars are given in the schedule hereto, as showing (a) that the meat to which it relates, or the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Secretary of State, and (b) that all necessary precautions for prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or to the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an official certificate; and where the certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.

The certificate hereby recognised replaces the certificates recognised on 14th September 1937, and 21st March 1939, which are hereby revoked.




