TRUNK ROADS AČT, 1946 BURNS OF REDPATH AND MEIKLE DRAMLACH DIVERSIÓNS

THE Secretary of State gives notice that he has made an Order under section 1 of the Trunk Roads Act, 1946, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which is that three diversions which he proposes to construct at the Burn of Redpath and the Burn of Meikle Dramlach in the County of Moray will become trunk roads on the date when the Order comes into operation and the lengths of trunk road to be superseded thereby will cease to be trunk roads on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the Moray County Council (who will thereafter become the highway authority responsible for those lengths) that the said diversions are opened for through traffic.

Copies of the Order, the title of which is "The Aberdeen-Huntly-Fochabers Trunk Road (Burns of Redpath and Meikle Dramlach Diversions) Order, 1962," can be purchased, price 3d., through any bookseller or direct from Her Majesty's Stationery Office, 13a Castle Street, Edinburgh 2.

Any Person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1946, or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of the nineteenth day of January 1962, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

If any objection is duly made to the proposed Order and is not withdrawn, the Secretary of State must, before making the Order, cause a Public Local Inquiry to be held with respect to the objection, and must consider the report of the person by whom the inquiry was held.
