#### MERCHANDISE MARKS ACT, 1926 MARKING OF IMPORTED FLOORING STRIPS

THE Board of Trade announce that in pursuance of the powers conferred on them by Section 3 of the Merchandise Marks Act, 1926, they have given a Direction, namely, the Merchandise Marks (Imported Goods) No. 3 Order, 1935, (Provisional Exemption) Direction, 1962 in regard to the Merchandise Marks (Imported Goods) No. 3 Order, 1935.

The Direction exempts imported flooring strips of the following descriptions from having to bear an indication of origin as prescribed by the Order and permits the indication to be stamped or stencilled on the goods:—

Maple or pine flooring strips, milled, measuring not less than  $\frac{7}{8}$  of an inch by not more than  $2\frac{1}{2}$  inches, of a length not less than 3 feet nor more than 18 feet, having a tongue along the whole length of one of the wider sides and a groove along the whole length of the other.

The Direction affords temporary relief only. The question whether this relief should be continued by an amendment to the Order in question is being referred to the
