ATHOLL ROAD, PITLOCHRY—WAITING RESTRICTIONS

THE Secretary of State hereby gives notice that he proposes to make an Order under section 26 of the Road Traffic Act, 1960 the effect of which is set out in the Schedule hereto.

SCHEDULE

Between 9 a.m. and 6 p.m. Mondays to Saturdays inclusive in Atholl Road (Route A.9), Pitlochry (1) waiting would be prohibited (a) on the north side from 10 yards east to 10 yards west of Bonnethill Road, from 16 yards east to 10 yards west of West Moulin Road and from Birnam Place to 10 yards west of Dysart Brae; and (b) on the south side from 12 yards east to 5 yards west of Station Road and from 10 yards east of Rie-Achan Road to 10 yards west of Dysart Brae: (2) unilateral waiting restrictions on the fixed day system would be imposed on the north side from 77 yards west of Newholme Avenue to 10 yards east of Bonnethill Road and from 10 yards west to 62 yards west of Bonnethill Road and on the south side from 77 yards west of Newholme Avenue to 62 yards west of Bonnethill Road; and 3) waiting would be limited to a period of twenty minutes any hour on the south side from 5 yards west of Station Road to 10 yards east of Rie-Achan Road.

Exceptions would be provided in the Order to enable a vehicle to wait in any of the lengths of road for so long as might be necessary for a person to board or alight, to enable goods to be loaded or unloaded or to enable a vehicle to be used in connection with any building operations or demolitions, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
